CHAIRMAN'S STATEMENT

Dear Shareholders:

On behalf of the board (the “Board”) of directors (the “Directors”) of Central Development Holdings Limited (the “Company”), I am pleased to present the annual report of the Company and its subsidiaries (collectively, the “Group”) for the year ended 31 March 2026 (the “Current Year”).

Over the past year, the global economic and market environment has been full of challenges. Geopolitical conflicts, international trade frictions, energy price volatility, and weak consumer sentiment have all exerted pressure on corporate operations. In the face of changes in the external environment, we have placed greater emphasis on operational quality, cash flow management, and business risk control, adjusting our business pace in response to market conditions.

During the Current Year, the Group recorded a total revenue of approximately HK\$104.9 million, representing a decrease from approximately HK\$228.1 million for the year ended 31 March 2025 (the “Previous Year”). The decrease in revenue was primarily attributable to the scaling down of the Group’s liquefied natural gas (“LNG”) sales business due to macroeconomic and industry fluctuations, as well as a decline in revenue from the jewelry business caused by a weak overall retail environment.

In terms of the energy business, the LNG market was impacted by changes in the international energy landscape, downward pressure on downstream demand, and price volatility, which put pressure on both gross profit margins and working capital requirements. Therefore, we proactively scaled down certain LNG supply chain sales businesses that required high capital commitments, and concentrated our resources on business opportunities with more manageable risk profiles and stronger sustainability. Concurrently, we established a new office in Hebei Province of the People’s Republic of China (the “PRC”), to strengthen our regional distribution and terminal delivery capabilities in Northern China. The refined oil sales business maintained stable operations. The Group’s filling station located in Chengdu of the PRC, continued to provide support for the energy business by leveraging its geographical location and surrounding logistics and transportation demand.

Regarding the jewelry business, revenue declined due to weak retail sentiment, high volatility in gold prices, and insufficient consumer confidence. In response to market changes, we maintained our core supply chain network while exploring online channels such as e-commerce and livestreaming retail to adapt to shifting consumption patterns. These initiatives have helped us accumulate experience and provided a reference for optimising our jewelry business model in the future.

Looking ahead, as the PRC’s 15th Five-Year Plan enters its initial stage, the transformation of the energy structure, green and low-carbon development, and energy digitalisation will continue to bring new development directions to the industry. The Group will closely monitor the pace of natural gas demand recovery, refined oil price trends, and downstream market changes, and flexibly adjust our procurement, inventory, and sales strategies under the premise of strictly controlling accounts receivable risks and ensuring reasonable profit margins. We will also prudently evaluate opportunities related to clean energy applications and energy management to align with policy guidance and market needs.

Chairman's Statement (Continued)

Facing an operating environment that remains complex, we will continue to adhere to the operating principle of “bottom-line thinking and seeking progress while maintaining stability,” strengthen risk control and capital management, control costs and non-core expenses, and maintain financial flexibility. We believe that through pragmatic operations and prudent decision-making, the Group will be able to consolidate its business foundation, gradually improve operational quality, and create long-term value for shareholders.

Finally, on behalf of the Board, I would like to express my sincere gratitude to all staff and the management team for their hard work and professional dedication in the face of a difficult environment during the Current Year. I would also like to extend my heartfelt thanks to our shareholders, customers, and business partners for their continuous trust and support of the Group.

MANAGEMENT DISCUSSION AND ANALYSIS

BUSINESS REVIEW

During the year ended 31 March 2026 (the “**Current Year**”), the Group was principally engaged in the energy business and the jewelry business. In the face of a complex and volatile global economic and market environment, the Group reviewed and optimised its overall business operating strategies during the Current Year.

During the Current Year, the Group’s total revenue amounted to approximately HK\$104.9 million (year ended 31 March 2025 (the “**Previous Year**”): approximately HK\$228.1 million). The decrease in revenue was mainly due to the scaled-down size of the Group’s liquefied natural gas (“**LNG**”) sales business resulting from macroeconomic and industry fluctuations, as well as a decline in revenue from the jewelry business.

Energy Business

During the Current Year, the Group was committed to providing diversified energy products as its primary objective. By collaborating with experienced partners in the industry, the Group actively developed its energy business, which mainly covers the sales of refined oil and the sales of LNG. During the Current Year, revenue from the energy business decreased from approximately HK\$221.3 million in the Previous Year to approximately HK\$101.9 million in the Current Year.

Against the backdrop of the People’s Republic of China (the “**PRC**”) gradually shifting from “dual control” of total energy consumption and intensity to “dual control” of total carbon emissions and intensity, as well as the progressive refinement of policies and assessment mechanisms related to carbon peaking and carbon neutrality (“**Dual Carbon**”), the energy industry has placed even greater emphasis on carbon emission management, energy efficiency, and low-carbon transformation. Driven by the Dual Carbon strategy, the development of non-fossil energy has accelerated. However, constrained by factors such as resource endowment, power grid infrastructure, and industrial technology maturity, the comprehensive replacement of traditional fossil energy by renewable energy still requires a relatively long development cycle. During this transition process, refined oil continues to play a fundamental supporting role in transportation and logistics operations, while natural gas will serve as a transitional energy source in the adjustment of the energy structure. Natural gas, characterised by its high efficiency, relatively low carbon footprint, and flexible dispatching, is a crucial transitional energy source in the energy transition process. According to data released by the National Development and Reform Commission of China, the apparent consumption of natural gas nationwide in 2025 was approximately 426.5 billion cubic meters, representing a year-on-year increase of 0.1%, maintaining overall stability.

However, the global energy supply chain remained affected by various external factors during the Current Year. Conflicts in Eastern Europe and the Middle East, the shipping situation in the Red Sea, policy changes in major economies, adjustments to international energy export and tariff policies, and macroeconomic fluctuations all impacted international natural gas prices and transportation costs. In the PRC market, influenced by warmer temperatures, adjustments in the real estate market, and weak demand from certain energy-intensive industries, some downstream demand faced pressure, and market competition intensified, which exerted pressure on the gross profit margin of the LNG sales business. To safeguard working capital and manage the credit risks associated with downstream customers, the Group adopted a prudent business contraction strategy, reducing the scale of the LNG supply chain sales business that requires high capital commitments. Management believes that maintaining a prudent liquidity position and managing balance sheet risks in a complex and volatile geo-economic environment is an important foundation for safeguarding the long-term interests of shareholders and other stakeholders.

Management Discussion and Analysis (Continued)

The refined oil sales business was similarly affected by the complex macroeconomic environment. At the international level, production policies of the Organisation of the Petroleum Exporting Countries and its non-OPEC oil-producing allies (OPEC+), geopolitical tensions in the Middle East, and fluctuations in international crude oil prices exposed the Group to higher and volatile procurement costs. Meanwhile, the domestic refined oil price adjustment mechanism and regional market competition also put pressure on downstream retail profit margins.

Despite this, the Group's refined oil business demonstrated strong operational resilience. According to data released by the Ministry of Public Security of the PRC, the number of motor vehicles nationwide reached 469 million by the end of 2025. Based on public information, non-new energy vehicles still account for the majority of the vehicle fleet. The Group's oil and gas filling station (the **"Filling Station"**) located in Qingbaijiang District of Chengdu of the PRC, is adjacent to an international railway express hub and multiple national highways and expressways. Leveraging its geographical advantages, it is well-positioned to serve application scenarios with stable demand, such as heavy-duty logistics. As a core area of the National Western Development Strategy and the "Belt and Road" initiative, Chengdu's vehicle ownership consistently ranks among the top nationwide. Its massive population base, vehicle fleet, and logistics transportation demand have brought a solid customer base to the Filling Station. According to the "2025 Chengdu National Economic and Social Development Statistical Bulletin," the city's motor vehicle ownership reached 8.155 million by the end of 2025, an increase of 6.7% from the end of the previous year, hitting another record high. The large vehicle fleet and logistics transportation demand provide a certain level of support for refined oil consumption in long-distance transportation, heavy-duty logistics, and daily traffic. In addition, the Group added a convenience store and car wash services at the Filling Station to promote synergy between refined oil sales and value-added services. This not only further enhanced the customer consumption experience but also consolidated the Filling Station's local market competitiveness, driving growth in revenue from the refined oil sales business. However, affected by fluctuations in international procurement costs and intensified price competition in certain localised areas, the overall profit margin of the refined oil sales business was still subject to a certain degree of compression.

Impacted by the dual effects of rising global trade protectionism (particularly the tariff and trade restriction policies of the United States and certain Western countries) and domestic overcapacity, market price competition for solar energy products intensified. Facing an unfavorable environment where industry-wide profit margins were squeezed, the Group adhered to strict risk control principles and adopted a strategy of maintaining a prudent wait-and-see approach regarding the operations of related products, so as to avoid incurring unnecessary financial losses amid fierce competition.

Jewelry Business

During the Current Year, the Group continued to operate its jewelry product sales business in the PRC and Hong Kong markets. Facing a complex business environment, management strove to maintain operational stability. However, impacted by macroeconomic headwinds and a weak overall retail environment, revenue from the jewelry business decreased by approximately 56.0% from approximately HK\$6.8 million in the Previous Year to approximately HK\$3.0 million in the Current Year.

During the Current Year, global economic uncertainty, geopolitical conflicts, and high volatility in gold prices continued to affect consumer sentiment and discretionary spending. The overall atmosphere in the retail and consumer goods market was weak, and end consumers tended to be cautious, which also prompted downstream supply chain customers to be more conservative when replenishing inventory, thereby affecting overall order demand. In the Hong Kong market, the weak retail environment and shifts in consumption patterns further dampened overall retail performance. This led to a temporary slowdown in the procurement cycles and expansion plans of the Group's Hong Kong customers. Consequently, the Group did not record any sales in the Hong Kong market during the Current Year.

Despite severe external challenges, the Group continued to maintain its core supply chain network in the PRC market and optimised internal operational efficiency. During the Current Year, the Group also explored online channels such as e-commerce and livestreaming retail. The preliminary results reflected that the Group possessed a certain degree of channel adjustment capability and provided a reference for the Group to optimise its jewelry business model in the future. We believe that by prudently controlling costs, maintaining stable supply chain relationships, and gradually expanding diversified sales channels, the jewelry business can enhance its adaptability in a challenging market environment.

PROSPECTS

The year 2026 marks the beginning of the PRC's 15th Five-Year Plan. The global political and economic landscape, energy markets, and supply chain environment will continue to face numerous uncertainties. Ongoing conflicts in Eastern Europe and the Middle East, as well as changes in the trade and foreign policies of major economies, are expected to continue bringing uncertainty to global supply chains and resource pricing. Facing a complex and volatile external environment, the Group will continue to adhere to the operating principle of "bottom-line thinking and seeking progress while maintaining stability," align with the PRC's energy structure transformation and green, low-carbon development policy directions, and strive to improve operational quality.

Consolidating the Energy Business Foundation and Prudently Seizing Opportunities

LNG, characterised by its high efficiency, low carbon footprint, and relative cleanliness, continues to be valued for its role as a transitional energy source in the energy transition process. With the advancement of the PRC's "Dual Carbon" strategy, the deepening of oil and gas system reforms, and the gradual expansion of application scenarios such as industrial use, city gas, transportation, and distributed energy, the medium- to long-term demand foundation for the natural gas market remains supported. Facing uncertainties such as geopolitical conflicts, international trade frictions, oil and gas price volatility, and seasonal supply and demand changes, the Group will continue to optimise the supply chain and customer structure of its LNG business. On the one hand, the Group will continue to identify medium- to long-term upstream supply sources with competitive costs and stable supply to enhance procurement flexibility and cost control capabilities; on the other hand, it will continue to expand diversified application scenarios and customer groups to mitigate the impact of short-term demand fluctuations on the business. During the Current Year, the Group established a new office network in Hebei Province of the PRC, further strengthening its regional distribution and terminal delivery capabilities in Northern China and improving its business network. Looking ahead, the Group will closely monitor changes in the international energy landscape, the pace of the PRC's natural gas demand recovery, and price trends. On the premise of ensuring reasonable profit margins and strictly controlling accounts receivable risks, the Group will flexibly adjust its distribution strategies and steadily advance the development of its LNG business.

Management Discussion and Analysis (Continued)

Refined oil remains an important foundational energy source supporting the national economy, transportation and logistics, engineering construction, and residents' daily lives. Although the penetration rate of new energy vehicles continues to rise, supported by factors such as the existing stock of traditional fuel vehicles, long-distance freight, engineering operations, and certain commercial vehicle application scenarios, it is expected that refined oil demand will maintain a certain foundation in the foreseeable future. Currently, traditional fuel vehicles and other non-new energy vehicles still account for the majority of the vehicle fleet, and refined oil will continue to play an important role in the transportation and logistics system in the short term. Meanwhile, according to data from the National Bureau of Statistics of the PRC, the crude oil processing volume of industrial enterprises above designated size in the PRC recorded year-on-year growth in 2025, reflecting that the domestic refining and supply system maintains a certain degree of resilience, providing foundational support for the refined oil market. The Group will continue to deeply cultivate its existing refined oil sales business, leverage the advantages of the Chengdu market and logistics hub, strengthen cost control and refined management, improve inventory turnover efficiency, and prudently evaluate the feasibility of upgrading and transforming the existing Filling Station into a comprehensive energy supply station. Looking ahead, the Group will closely monitor refined oil price trends, downstream demand changes, and the regional competitive landscape, and flexibly adjust procurement, inventory, and sales strategies to enhance business resilience and operational efficiency.

Grasping Policy Guidance to Promote Energy Structure Optimisation

As the national "Dual Carbon" strategy steadily advances and policies related to clean energy, energy digitalisation and intelligentisation continue to improve, the role of natural gas in a diversified and synergistic energy supply system continues to be emphasised. At the same time, directions such as the synergistic development of green power, energy digitalisation, and computing power infrastructure also provide policy support for the energy industry to improve operational efficiency and explore digital transformation. The Group will continue to monitor relevant policies and market development trends, and in conjunction with its existing energy business foundation, prudently study potential directions such as synergy between green power and computing infrastructure, energy digital management, and clean energy applications. Currently, the Group is conducting preliminary data collection and evaluating potential cooperation opportunities in areas with clean energy resources and relevant supporting conditions, such as Zhangjiakou City, Hebei Province. Such work remains at the preliminary research stage and does not constitute any commitment by the Group to any major investment or business transformation. The Group will prudently determine subsequent arrangements depending on the policy environment, market conditions, resource availability, and feasibility assessment results. Facing uncertainties such as geopolitics, the international energy landscape, technological shifts, and the macroeconomy, the Group will continue to monitor policy and market changes, prudently evaluate relevant opportunities, and adjust business strategies in a timely manner to maintain operational stability and promote sustainable development.

Broadening Jewelry Sales Channels and Optimising the Business

The jewelry industry is expected to continue to be affected by factors such as global political and economic uncertainties, a slow economic recovery, and high volatility in precious metal prices, rendering the overall operating environment challenging. Impacted by the weak overall economic environment, consumers may continue to maintain a cautious attitude toward high-end and discretionary consumer goods in the short term, which is expected to bring sustained operational pressure to the overall jewelry market. Management expects that industry competition and consolidation will continue for some time in the future. However, we remain cautiously confident in the adaptability and long-term development of our jewelry business. Leveraging the preliminary experience gained by the Group in e-commerce and online channels in the PRC, the Group will gradually promote the diversification of its product portfolio to align with changes in consumer preferences. We will also continue to maintain financial prudence and carefully navigate changes in the retail environment of the Hong Kong market. We believe that our established supply chain foundation and preliminary experience in expanding new sales channels will help the Group cope with external economic challenges and enhance the adaptability and long-term competitiveness of the jewelry business.

Optimising Risk Control and Capital Allocation

Against the backdrop of increasing geopolitical risks and macroeconomic volatility, cash flow management and maintaining a robust capital structure are of paramount importance to the Group. During the Current Year, the Group completed certain capital structure optimisation measures, including the cancellation of the Convertible Bonds (as defined below) and the Loan Capitalisation (as defined below), which contributed to the improvement of its current ratio and reduced short-term repayment pressure. The Group will continue to implement strict cost control measures, streamline non-core expenses, and closely monitor various working capital indicators. Furthermore, management will continue to review the Group's capital structure, liquidity position, and funding needs, and where appropriate, prudently evaluate various financing options to support the Group's operations and long-term development. As at the date of this report, save as otherwise announced by the Company, the Group has not made any final decision regarding any specific financing plan. These measures are expected to help the Group maintain financial flexibility, cope with potential macroeconomic fluctuations, and support future business development needs.

FINANCIAL REVIEW

Revenue

Revenue of the Group for the Current Year was approximately HK\$104.9 million, representing a decrease of approximately 54.0% as compared to approximately HK\$228.1 million for the Previous Year. The decrease was mainly attributable to the combined decline in the revenue of both the energy business and the jewelry business.

Revenue of the energy business decreased by approximately 54.0% from approximately HK\$221.3 million for the Previous Year to approximately HK\$101.9 million for the Current Year. This decrease was primarily attributable to the contraction in the sales of LNG products amid market volatility, cautious procurement by downstream customers and the Group's prudent strategy to reduce lower-margin and capital-intensive sales of LNG products. This was partially offset by the resilient growth recorded in the sales of refined oil during the Current Year.

Revenue of the jewelry business decreased by approximately 56.0% from approximately HK\$6.8 million for the Previous Year to approximately HK\$3.0 million for the Current Year. This decrease was mainly attributable to softer demand and fluctuations in precious metal prices, which affected sales momentum in the jewelry market.

Cost of Sales and Gross Profit

Cost of sales of the Group for the Current Year was approximately HK\$97.2 million, representing a decrease of approximately 55.2%, as compared to approximately HK\$216.8 million for the Previous Year. Gross profit decreased from approximately HK\$11.3 million for the Previous Year to approximately HK\$7.6 million for the Current Year, representing a decrease of approximately 32.2%. The decreases in both cost of sales and gross profit were generally in line with the contraction in overall sales volume. Although certain energy products, including LNG and refined oil, continued to face margin pressure, the Group adopted a prudent procurement and inventory management strategy during the Current Year. Together with the scaling back of lower-margin products and the focus on risk control, these measures helped mitigate the impact of the revenue decline and contributed to the improvement in the Group's overall gross profit margin.

Management Discussion and Analysis (Continued)

Other Income

Other income decreased from approximately HK\$5.2 million for the Previous Year to approximately HK\$2.6 million for the Current Year, representing a decrease of approximately 49.6%. This decline was mainly due to the early termination of a lease agreement for one of the Group's factory premises and the resulting vacant period during the Current Year. Following the early termination of the aforementioned lease, the Group has been actively optimising its tenant mix. The Group has secured a new tenant for part of the vacated premises, with the new lease commencing in April 2026. Management is also in active negotiations with other prospective tenants for the remaining vacant space, with a view to stabilising and improving rental income.

Other Gains and Losses, Net

The Group recorded net other gains of approximately HK\$2.8 million for the Current Year (2025: HK\$6.3 million). The net gains mainly comprised a loss from a change in fair value of investment properties of approximately HK\$0.6 million (2025: approximately HK\$8.5 million), a gain on fair value changes of derivative financial instruments relating to the Convertible Bonds of approximately HK\$1.6 million (2025: approximately HK\$14.9 million) and a gain on disposal of interest in an associate of approximately HK\$1.7 million (2025: nil).

Impairment Loss Reversed (Recognised) under Expected Credit Loss ("ECL") Model

The Group recorded a reversal of impairment loss on trade receivables under the ECL model of approximately HK\$0.2 million for the Current Year (2025: impairment loss recognised approximately HK\$0.5 million). The management of the Group will continue to conduct regular reviews of the debtors' repayment histories, resources and financial capabilities to ensure the ability of repayment within the credit period.

Selling and Distribution Costs

Selling and distribution costs decreased from approximately HK\$2.6 million in the Previous Year to approximately HK\$2.2 million in the Current Year, representing a decrease of approximately 16.8%, which was mainly attributable to the decrease in transportation costs in line with the lower sales volume in the Current Year.

Administrative Expenses

Administrative expenses for the Current Year primarily comprised staff costs, directors' remuneration, auditor's remuneration, legal and professional fees, rent, rates and management fees, and other administrative expenses including depreciation and amortisation. Administrative expenses decreased from approximately HK\$21.4 million for the Previous Year to approximately HK\$19.2 million for the Current Year, representing a decrease of approximately 10.4%, which was mainly attributable to the Group's continued implementation of cost control measures during the Current Year.

Finance Costs

Finance costs decreased from approximately HK\$16.8 million for the Previous Year to approximately HK\$16.5 million for the Current Year, representing a decrease of approximately 1.7%. Finance costs represented the imputed interest derived from the long-term loans from a shareholder of approximately HK\$0.2 million (2025: HK\$2.5 million), the imputed interest derived from the interest-free convertible bonds of approximately HK\$6.6 million (2025: HK\$8.4 million), the interest derived from the long-term loans from a controlling shareholder of approximately HK\$8.8 million (2025: HK\$4.1 million), the interest derived from lease liabilities of approximately HK\$0.1 million (2025: HK\$0.2 million) and the interest derived from the long term bank loans of approximately HK\$0.8 million (2025: HK\$1.5 million) for the Current Year.

Share of Results of an Associate

Share of result of an associate represented the Group's share of loss of Chengdu Huahan Energy Co., Ltd.* (成都華漢能源有限公司) ("**Chengdu Huahan**") of approximately HK\$0.5 million (2025: HK\$0.7 million) for the Current Year.

Income Tax Expense/(Credit)

The Group recorded income tax expense of approximately HK\$0.7 million for the Current Year (2025: income tax credit of approximately HK\$1.1 million). The amount mainly represented the PRC enterprise income tax and the deferred tax arising from the investment properties of the Group during the Current Year.

Loss for the Year Attributable to the Owners of the Company

By reason of the factors stated above, the loss for the year attributable to the owners of the Company increased from approximately HK\$19.2 million for the Previous Year to approximately HK\$25.9 million for the Current Year, representing an increase of approximately 35.1%. Basic loss per share was 6.04 HK cents (2025: 4.79 HK cents).

Final Dividend

The Board does not recommend the payment of a final dividend for the Current Year (2025: nil).

Liquidity and Financial Position

As at 31 March 2026, the Group recorded net current assets of approximately HK\$34.9 million and a current ratio of approximately 1.9 (31 March 2025: net current liabilities of HK\$26.9 million and 0.7), respectively.

As at 31 March 2026, cash and cash equivalents amounted to approximately HK\$23.6 million (31 March 2025: HK\$17.0 million). Inventories stood at approximately HK\$6.6 million (31 March 2025: HK\$4.4 million), representing the refined oil and solar module intelligent technology products. Trade receivables and trade payables amounted to approximately HK\$0.1 million and HK\$0.3 million respectively (31 March 2025: HK\$4.5 million and HK\$4.4 million respectively), both of which were derived from the energy business and the jewelry business. During the Current Year, the Group's liquidity position improved significantly following the cancellation of the Convertible Bonds. As at 31 March 2025, the Convertible Bonds were classified as current liabilities, which had resulted in the Group's current liabilities exceeding its current assets by approximately HK\$26.9 million. Upon the automatic cancellation of the Convertible Bonds on 1 December 2025, the related substantial current liability was fully derecognised. For further details on the cancellation, please refer to the section headed "Convertible Bonds" below in this "Management Discussion and Analysis" section. Furthermore, the Group continues to implement stringent cost-saving initiatives, specifically focusing on reducing non-core and unessential operations and expenses, in order to continuously enhance the Group's financial position. The Board considers that, after taking into account the Group's cash resources, expected operating cash flows, available financing arrangements and the maturity profile of its borrowings and shareholder loans, the Group has sufficient working capital for its present requirements.

As at 31 March 2026, the Group's property, plant and equipment, right-of-use assets and investment properties amounted to approximately HK\$14.3 million, HK\$6.9 million and HK\$76.3 million, respectively (31 March 2025: HK\$14.8 million, HK\$7.9 million and HK\$73.6 million respectively). The investment properties of the Group are located at No. 61, Haichao Road, Sino-Italy Ningbo Ecological Park (also known as Zhongyi Ningbo Shengtai Park), Yuyao City of Zhejiang Province, the PRC, for industrial use and are held as operating leases, which generate rental income. The investment properties were valued by an independent firm of professional property valuer and the fair value of the investment properties was derived using the income approach for both years.

Management Discussion and Analysis (Continued)

As at 31 March 2026, the net carrying amount of the intangible assets was approximately HK\$44.5 million (31 March 2025: HK\$44.2 million), representing the operating rights in relation to the relevant certificates, licenses and approvals for the operations of the filling station and the sale of refined oil with finite useful lives. The intangible assets arose from the Group's acquisition of Chengdu Kaibangyuan Trading Co., Limited* (成都凱邦源商貿有限公司).

Capital Resources and Gearing

As at 31 March 2026, the Group's secured interest-bearing bank borrowings amounted to approximately HK\$18.1 million (31 March 2025: HK\$30.8 million) and bore fixed interest rates ranging from 3.1% to 3.95% per annum (31 March 2025: at fixed rates ranging from 3.95% to 4.5%), of which approximately HK\$3.0 million (31 March 2025: HK\$13.5 million) were repayable within one year and approximately HK\$15.1 million (31 March 2025: HK\$17.3 million) were repayable after one year. The Group's gearing ratio (which was expressed as a percentage of total bank borrowings over total equity) was approximately 77.0% as at 31 March 2026 (31 March 2025: 259.6%).

Such bank borrowings were secured by the Group's assets, for details of the charges on the Group's assets, please refer to the section headed "Charges on Group Assets" below in this "Management Discussion and Analysis" section. Save as disclosed above, the Group had no other banking facilities (31 March 2025: nil).

Connected Transaction in relation to the Loan Capitalisation

During the Current Year, the Group took proactive steps to improve its financial position. On 28 November 2025, the Company, Mr. Hu Yangjun ("**Mr. Hu**") (as creditor), and Oceanic Capital (HK) Limited ("**Oceanic Capital**") (as subscriber), a company wholly owned by Mr. Hu, entered into a loan capitalisation agreement (the "**Loan Capitalisation Agreement**"). Pursuant to the Loan Capitalisation Agreement, Oceanic Capital conditionally agreed to subscribe for, and the Company allotted and issued 87,500,000 capitalisation shares (the "**Capitalisation Shares**") at a price of HK\$0.4 per Capitalisation Share under a specific mandate. The aggregate subscription price of HK\$35.0 million was satisfied by capitalising and setting off against a partial amount of the loan due to Mr. Hu (the "**Loan Capitalisation**").

As Oceanic Capital is wholly owned by Mr. Hu, who is an executive Director and a controlling shareholder of the Company (beneficially owning approximately 50.52% of the issued share capital of the Company at the material time), Oceanic Capital is an associate of Mr. Hu and, therefore, a connected person of the Company under Chapter 14A of the Rules Governing the Listing of Securities on the Main Board (the "**Listing Rules**") of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**"). Accordingly, the Loan Capitalisation constituted a connected transaction and was subject to the reporting, announcement, and independent shareholders' approval requirements. Mr. Hu and his associates abstained from voting on the relevant resolution at the extraordinary general meeting of the Company (the "**EGM**").

Following the approval by the independent shareholders at the EGM held on 20 January 2026 and the grant of the listing approval by the Listing Committee of the Stock Exchange, the Loan Capitalisation was completed on 22 January 2026. The 87,500,000 Capitalisation Shares represented approximately 17.51% of the total number of issued shares as enlarged by such allotment and issue. For further details, please refer to the Company's announcements dated 28 November 2025 and 20 January 2026, and the circular dated 29 December 2025.

Following the completion of the aforementioned loan capitalisation, the unsecured interest bearing loans due to a controlling shareholder amounted to approximately HK\$123.2 million as at 31 March 2026 (31 March 2025: HK\$110.9 million). The loan bore a fixed interest rate of 8% per annum (31 March 2025: 8%) and are repayable after one year from the end of the Current Year. The increase in such loans was mainly attributable to additional advances made by the controlling shareholder and interest accrued during the Current Year, partially offset by the Loan Capitalisation. As at 31 March 2026, the unsecured interest-free loans due to a shareholder amounted to approximately HK\$3.9 million (31 March 2025: HK\$12.9 million), which will be repayable after one year from the end of the Current Year.

The Group principally met its working capital requirements and other liquidity requirements through a combination of operating cash flows, bank borrowings and loans due to a controlling shareholder and a shareholder during the Current Year.

Disposal of a 35% Equity Interest in an Associate, Chengdu Huahan

As disclosed in the Company's previous annual reports and announcements, the Group originally completed the acquisition of a 35% equity interest in Chengdu Huahan, an associate of the Group, from Mr. Zhang Bing (the "Vendor") on 5 December 2022. The initial consideration of HK\$52,000,000 was satisfied by the issuance of convertible bonds (the "Convertible Bonds") to the Vendor. As the Vendor is a Director of the Company and a substantial shareholder of certain subsidiaries, he is a connected person under Chapter 14A of the Listing Rules, making the transaction a discloseable and connected transaction.

Pursuant to a second supplemental agreement dated 12 June 2024, the parties agreed that if Anhui Huagang Bochen New Energy Co., Ltd. ("Anhui Huagang"), a joint venture owned by Chengdu Huahan, failed to obtain a specific gas business license on or before 30 November 2025, the Group would re-transfer its 35% equity interest in Chengdu Huahan back to the Vendor at nil consideration, and the Convertible Bonds would be automatically cancelled (the "Cancellation and Re-Transfer Arrangement").

As the progress of the license application was beyond Anhui Huagang's control, the license was not obtained by the 30 November 2025 deadline. Consequently, the Group completed the disposal by re-transferring its 35% equity interest to the Vendor, and the Convertible Bonds were officially cancelled on 1 December 2025. Details of the original acquisition and the supplemental agreements were set out in the Company's announcements dated 19 August 2022, 15 November 2022, 5 December 2022, and 12 June 2024, and the circulars dated 18 November 2022 and 3 July 2024.

Convertible Bonds

On 5 December 2022, the Company issued the Convertible Bonds in the principal amount of HK\$52,000,000 to the Vendor as the consideration for the acquisition of the 35% equity interest in Chengdu Huahan. The Convertible Bonds were convertible into a maximum of 70,270,270 new shares of the Company at a conversion price of HK\$0.74 per conversion share (subject to adjustment).

Management Discussion and Analysis (Continued)

As disclosed in the section headed “Disposal of a 35% Equity Interest in an Associate, Chengdu Huahan” above, the conditions for maintaining the investment were not met, triggering the Cancellation and Re-Transfer Arrangement. Accordingly, the Convertible Bonds were automatically cancelled in full on 1 December 2025. Consequently, as at 31 March 2026, the carrying amount of the debt component and the fair value of the derivative financial instrument derived from the Convertible Bonds were both nil (31 March 2025: approximately HK\$45.4 million and HK\$2.1 million, respectively). A net gain on disposal of interest in an associate of approximately HK\$1.7 million was recognised in the Current Year.

Capital Structure

The Group’s total assets and total liabilities as at 31 March 2026 amounted to approximately HK\$215.8 million (31 March 2025: HK\$263.8 million) and approximately HK\$192.2 million (31 March 2025: HK\$252.0 million), respectively. The Group’s debt ratio (which was expressed as a percentage of total liabilities over total assets) was approximately 89.1% as at 31 March 2026 (31 March 2025: 95.5%).

Charges on Group Assets

As at 31 March 2026, buildings with carrying amounts of approximately HK\$3.1 million (31 March 2025: HK\$10.6 million), the right-of-use assets with carrying amounts of approximately HK\$4.9 million (31 March 2025: HK\$6.6 million) and the investment properties with carrying amounts of approximately HK\$76.3 million (31 March 2025: HK\$73.6 million) were pledged to secure bank borrowings of approximately HK\$18.1 million (31 March 2025: HK\$30.8 million) granted by banks in the PRC to the Group.

Save as disclosed above, there were no other charges on the Group’s assets as at 31 March 2026.

Capital Commitments and Contingent Liabilities

As at 31 March 2026, the Group did not have any capital commitments (31 March 2025: nil) or contingent liabilities (31 March 2025: nil).

Employee and Remuneration Policy

As at 31 March 2026, the Group had a total of 63 employees (31 March 2025: 64). The Group remunerates its employees based on their performance, work experience and the prevailing market rates. Salaries of employees are maintained at competitive levels while bonuses are granted by reference to the performance of the Group and individual employees.

The Group also provides internal training to employees when necessary and other staff benefits which include a share option scheme and corporate contributions to the statutory mandatory provident fund scheme to its employees in Hong Kong and the statutory central pension schemes to its employees in the PRC.

Furthermore, the remuneration committee of the Board (the “**Remuneration Committee**”) will review and make recommendations to the Board as to the compensation packages of the Directors and senior management of the Group with reference to salaries paid by comparable companies, time commitment and responsibilities of the Directors and senior management of the Group.

Foreign Exchange Fluctuation and Hedging

The business operations of the Group's subsidiaries were conducted mainly in the PRC and Hong Kong with sales and purchases of the Group's subsidiaries denominated mainly in Hong Kong dollars, Renminbi and United States dollars ("USD"). The Group's cash and bank deposits were denominated in Hong Kong dollars, Renminbi and USD as well. Any significant exchange rate fluctuation of Hong Kong dollars against USD or Renminbi may have financial impacts on the Group. While the Group would closely monitor the volatility of the foreign exchange rate, the Directors considered that the Group's exposure to foreign exchange rate fluctuations remained minimal.

As at 31 March 2026, no forward foreign currency contracts were designated in hedging accounting relationships (31 March 2025: nil).

Significant Investments, Material Acquisitions and Disposals of Subsidiaries and Affiliated Companies

Save as disclosed in this report, there were no significant investments, material acquisitions and disposals of subsidiaries, associates and joint ventures during the Current Year.

Future Plans for Material Investments or Capital Assets

Save as disclosed in this report, the Group did not have any plans for material investments or capital assets as at 31 March 2026.

DIRECTORS AND COMPANY SECRETARY

EXECUTIVE DIRECTORS

Mr. Wu Hao (“Mr. Wu”), aged 52, is our chairman and an executive Director. He joined the Group in February 2012 and is responsible for overall strategic planning and development. He has held directorship position within the other members of the Group. Mr. Wu has corporate management experience in natural resources business. Mr. Wu graduated in legal professional studies from Correspondence Institute of Party School of the Central Committee of Communist Party of China* (中共中央黨校函授學院) in 2002.

Mr. Hu Yangjun (“Mr. Hu”), aged 53, is an executive Director. He joined the Group in November 2011 and is responsible for reviewing and improving the operations of the Group. Mr. Hu has corporate management experience in information technology, international trade and energy and environmental protection. Mr. Hu graduated from Anhui Normal University and he was a member of All-China Youth Federation. Mr. Hu has worked as senior management in Zhejiang Orient Financial Holdings Group Co., Ltd* (浙江東方金融控股集團股份有限公司) (stock code: 600120) and Insigma Technology Co., Ltd* (浙大網新科技股份有限公司) (stock code: 600797), both companies listed on The Shanghai Stock Exchange. Mr. Hu was previously an executive director of Shenghua Lande Scitech Limited (stock code: 8106) and Neo Telemedia Limited (stock code: 8167), both companies listed on the GEM of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). He also served as a director of Asia Environmental Holdings Limited, which was listed on the Singapore Stock Exchange.

Mr. Li Wei Qi, Jacky (“Mr. Li”), aged 54, is an executive director. He is a member of the Remuneration Committee and the Nomination Committee. Mr. Li joined the Group in November 2011 as a non-executive Director and re-designated as an executive Director in January 2025. He is responsible for business policy formulation and execution of the Group. Mr. Li has experience in the financial services field. Mr. Li served as the vice president of the marketing department of Emperor Bullion Investments (Asia) Limited, Emperor Futures Limited, Emperor Securities Limited and Emperor Wealth Management Limited, and the vice president of the marketing department of Tanrich Futures Limited. He was also a person licensed by the Securities and Futures Commission (the “SFC”) for dealing and advising in futures contracts and asset management. Mr. Li is a licensed representative under the Securities and Futures Ordinance (the “SFO”) to carry on Type 1 (dealing in securities) and Type 2 (dealing in futures contracts) regulated activities.

Mr. Zhang Bing (“Mr. Zhang”), aged 55, was appointed as an executive Director in February 2023. He is a director of Chengdu Kaibangyuan Trading Co., Limited* (成都凱邦源商貿有限公司), an indirect non-wholly-owned subsidiary of the Group. Mr. Zhang obtained a Master of Business Administration degree from the Asia Metropolitan University in 2017 and was admitted to the CEO program of Cheung Kong Graduate School of Business (長江商學院) in 2020. Mr. Zhang has engaged in the energy business for over 25 years and has held management positions in a number of Chinese companies in the oil and gas industry. He has extensive experience in business development, sales and marketing and business operation in the industry.

Mr. Tang Shukuan (“Mr. Tang”), aged 50, is an executive Director. Mr. Tang joined the Company in August 2025. He currently serves as the general manager of Beijing Jingyan Jiesuan Technology Co., Limited* (北京精演捷算科技有限公司) and the director of Zhangjiakou Chabei Jingyan Jiesuan Technology Co., Limited* (張家口察北區精演捷算科技有限公司), both of which are indirect subsidiaries of the Group. Mr. Tang has over 20 years of experience in administrative management. He has held various management positions at several educational institutions in Beijing and possesses extensive experience in optimising administrative management systems. He has also accumulated professional expertise in the business areas of the Group. Mr. Tang graduated with a bachelor’s degree in law from the Xi’an Political College of the People’s Liberation Army of China in 2005.

INDEPENDENT NON-EXECUTIVE DIRECTORS

Mr. Jin Qingjun (“Mr. Jin”), aged 68, was appointed as an independent non-executive Director in October 2017. He is the chairman of the Remuneration Committee and the Nomination Committee, and a member of the Audit Committee. Mr. Jin is currently a partner of Beijing Redsunny Law Firm and a legal counsel for various securities companies and listed companies. His major areas of practice include securities, finance, investment, corporate, insolvency as well as foreign-related legal affairs. Mr. Jin is one of the first lawyers who were granted Securities Qualification Certificate in the PRC and has focused on securities-related legal affairs for more than 20 years. Mr. Jin previously served as General Counsel of Shenzhen Stock Exchange and a member of its Listing Supervisory Council, and was a senior partner of King & Wood Mallesons. In 2012, he was named one of the Top 10 PRC Lawyers of the Year and PRC Securities Lawyer of the Year. Mr. Jin has been a non-executive director and chairman of the board of Goldstone Capital Group Limited (stock code: 1160), a company listed on the Stock Exchange, since January 2026. He has also been an independent non-executive director of Times China Holdings Limited (stock code: 1233) since October 2015, Goldstream Investment Limited (stock code: 1328) since December 2019 and Prinx Chengshan Holdings Limited (stock code: 1809) since September 2023, all companies listed on the Stock Exchange. He has also been a director of Shenzhen Kingkey Smart Agriculture Times Co. Ltd. (stock code: 000048), a company listed on the Shenzhen Stock Exchange, since September 2018, and an independent director of Zhongtai Securities Company Limited (stock code: 600918), a company listed on the Shanghai Stock Exchange, since April 2024. Mr. Jin was an independent director of Shenzhen Cheng Chung Design Co. Ltd. (stock code: 002811), a company listed on the Shenzhen Stock Exchange, and an independent non-executive director of Bank of Tianjin Co., Ltd, a company listed on the Stock Exchange (stock code: 1578), Sino-Ocean Group Holding Limited, a company listed on the Stock Exchange (stock code: 3377), Guotai Junan Securities Co., Ltd., a company listed on the Stock Exchange (stock code: 2611) and the Shanghai Stock Exchange (stock code: 601211). Mr. Jin obtained a bachelor of the arts in English from Anhui University. He received a master's degree in International Law from China University of Political Science and Law. Mr. Jin is an adjunct professor at Renmin University of China Lawyer College, a visiting scholar of the John F. Kennedy School of Government, Harvard Kennedy School, an arbitrator of Shenzhen Court of International Arbitration and Arbitration Foundation of Southern Africa, a member of the Inter-Pacific Bar Association, and the PRC legal counsel of US Court of Appeals for the Washington D.C Circuit.

Ms. Zhong Yingjie, Christina (“Ms. Zhong”), aged 57, was appointed as an independent non-executive Director in October 2021. She is the chairman of the Audit Committee. Ms. Zhong has experience in the accounting and auditing field, she is currently a senior advisor to chairman of Hopu Investments. She is a certified public accountant in the PRC and worked for the National Audit Office of the PRC. Ms. Zhong also has extensive experience in finance and capital markets. Ms. Zhong had worked for Morgan Stanley Asia Limited from 2008 to 2017 and served as a Managing Director and the head of division of financial institutions in China. Ms. Zhong had also served in various capacities in the past, including an Executive Director of Goldman Sachs Gao Hua Securities Company Limited and a Vice President of China International Capital Corporation Limited. Ms. Zhong had served as an Independent Non-Executive Director of China Shenhua Energy Company Limited, a company dual listed on The Stock Exchange of Hong Kong Limited (stock code: 1088) and the Shanghai Stock Exchange (stock code: 601088). Ms. Zhong graduated from Wuhan University in Auditing with a bachelor's degree and obtained a master's degree in Business and Administration from China Europe International Business School (CEIBS).

Directors and Company Secretary (Continued)

Mr. Lan Yadong (“Mr. Lan”), aged 58, was appointed as an independent non-executive Director in January 2025. He is a member of the Audit Committee, the Remuneration Committee and the Nomination Committee. He obtained a Bachelor’s degree of Management Science from Shandong University in 1989, has over 35 years working experience in finance, insurance and corporate management. He served as deputy head of preparatory group for Hengqin Life Insurance Co., Ltd. in 2016, while concurrently holding the position of the vice chairman of Zhuhai Huachuang Venture Capital Management Co., Ltd.* (珠海鐸創投資管理有限公司). He has then been the chairman of the board of Hengqin Life Insurance Co., Ltd. from 2017 to 2024. Previously, Mr. Lan held various positions, including deputy president, person-in-charge of finance and executive director of PICC Life Insurance Company Limited, the chairman of the board of China-US International Insurance Sales & Services Company Ltd, general manager of personal insurance department of China Life Insurance Company Ltd. Mr. Lan has obtained the qualification of the chairman of the board approved by the former China Insurance Regulatory Commission, and is currently an independent director of Pramerica Fosun Life Insurance Co., Ltd..

COMPANY SECRETARY

Mr. Chow Chi Shing (“Mr. Chow”) is the financial controller and company secretary of the Group. He joined the Group in 2015 and is responsible for the financial and accounting and company secretarial matters of the Group. Mr. Chow is experienced in the accounting and finance field, as well as in company secretarial practices. He worked in a leading international audit firm, companies listed on the Stock Exchange and a multi-national corporation. Mr. Chow graduated with a bachelor’s degree in accounting from the Hong Kong University of Science and Technology. Mr. Chow is a member of the Hong Kong Institute of Certified Public Accountants and a fellow member of the Association of Chartered Certified Accountants in the United Kingdom.

CORPORATE GOVERNANCE REPORT

COMPLIANCE WITH THE CORPORATE GOVERNANCE CODE

The Company continues to achieve high standards of corporate governance which, it believes, is crucial to the development of the Company and to safeguard the interest of the shareholders of the Company (the “Shareholder(s)”).

The Board and the management of the Company are committed to the establishment of good corporate governance practices and procedures. The corporate governance principles of the Company emphasise effective internal control, accountability and transparency of the Board and are adopted in the best interests of the Company and its Shareholders.

Accordingly, the Company has adopted the code provisions set out in the Corporate Governance Code (the “CG Code”) contained in Appendix C1 to the Listing Rules as its own code on corporate governance practices.

The Company has applied the principles and complied with all the applicable code provisions set out in the CG Code throughout the Current Year.

MODEL CODE FOR SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the “Model Code”) as set out in Appendix C3 to the Listing Rules as its own code of conduct regarding securities transactions by the Directors. Having made specific enquiries with all Directors, they confirmed that they had complied with the required standards set out in the Model Code throughout the Current Year.

The Company has also established written guidelines on no less exacting terms than the Model Code for securities transactions by relevant employees who are likely to possess inside information of the Company.

BOARD OF DIRECTORS

The Board sets directions and formulates the overall strategies for the Group, monitors its overall performance and maintains effective supervision over the management running the Group through relevant committees of the Board. In particular, the Board oversees the implementation of strategies by management, reviews the operational and financial performance, and provides oversight to ensure that a sound system of internal control and risk management is in place. Each Director ensures that he/she carries out his/her duties in good faith and compliance with the standards of applicable laws and regulations, and acts in the interest of the Company and its Shareholders at all times.

BOARD COMPOSITION

As at the date of this report, the Board comprises eight Directors, including five executive Directors, namely, Mr. Wu Hao, the chairman of the Board (the “Chairman”), Mr. Hu Yangjun, Mr. Li Wei Qi, Jacky, Mr. Zhang Bing and Mr. Tang Shukuan; and three independent non-executive Directors, namely, Mr. Jin Qingjun, Ms. Zhong Yingjie, Christina and Mr. Lan Yadong. Biographical details of the Directors are set out under the section “Directors and Company Secretary” on pages 16 to 18 of this annual report. The composition of the Board is in accordance with the requirement of Rule 3.10 and 3.10A of the Listing Rules. There are three independent non-executive Directors and one of them has an accounting professional qualification. One-third of the members of the Board are independent non-executive Directors. In compliance with code provision C.1.8 of Part 2 of the CG Code, the Company has arranged appropriate insurance cover in respect of potential legal actions against its Directors.

Corporate Governance Report (Continued)

During the Current Year, the Company appointed Mr. Tang Shukuan as an executive Director. Mr. Tang Shukuan had obtained the legal advice as referred to in Rule 3.09D of the Listing Rules on 4 August 2025, and Mr. Tang Shukuan has confirmed that he understood his obligations as a director of a listed issuer.

The presence of three independent non-executive Directors is considered by the Board to be a reasonable balance between executive and non-executive Directors. The Board is of the opinion that such balance can provide adequate checks and balances to safeguard the interests of Shareholders and the Group. The independent non-executive Directors provide the Group with a wide range of expertise and experience so that independent judgement can be exercised effectively. They have also participated in Board meetings and general meetings, dealt with potential conflicts of interest, served on the audit committee of the Board (the “Audit Committee”), the Remuneration Committee and the nomination committee of the Board (the “Nomination Committee”) and scrutinized the Group’s performance and reporting. Through their active participation, the management process of the Company can be critically reviewed and controlled.

The Directors have distinguished themselves in their field of expertise, and have exhibited high standards of personal and professional ethics and integrity. All Directors have given sufficient time and attention to the Company’s affairs. The Board believes that the ratio between executive Directors and independent non-executive Directors provides reasonable and adequate checks and balances for the Board in the decision making process. The Board is responsible for the appointment of new Director and nomination for re-election by the Shareholders at the annual general meeting of the Company. Under the articles of association of the Company (the “Articles of Association”), the Board may from time to time appoint a Director either to fill a vacancy or as an addition to the Board. Any new Director appointed to fill a casual vacancy or as an addition to the existing Board shall hold office until the next annual general meeting after his/her appointment and shall then be eligible for re-election at such meeting.

INDEPENDENCE

The Company has received an annual confirmation of independence from each of the independent non-executive Directors in accordance with Rule 3.13 of the Listing Rules and each of them has declared fulfilment of all the criteria for assessing independence in accordance with Rule 3.13 of the Listing Rules. Accordingly, the Company considers that all the independent non-executive Directors are independent.

All independent non-executive Directors are identified as such in all corporate communications containing the names of the Directors.

BOARD AND GENERAL MEETINGS

During the Current Year, twelve full Board meetings and two general meetings were held. The Directors attended those meetings in person, by phone or through other electronic means of communication. The external auditor attended the Company's annual general meeting held on 11 September 2025 (the "2025 AGM") and the Company's extraordinary general meeting held on 20 January 2026 (the "EGM") through electronic means of communication to answer questions. - independent professional advice would be provided to the independent non-executive Directors upon reasonable request to assist them in performing their duties to the Company.

The Board has reviewed the implementation and effectiveness of the Board independence mechanism set out above for the year ended 31 March 2026, and considers it to be adequate and effective.

The Board performs the corporate governance duties of the Group, and is mainly responsible for:

- developing and reviewing the corporate governance policies and practices of the Company;
- reviewing and monitoring the training and continuous professional development of Directors and senior management;
- reviewing and monitoring the policies and practices on compliance with legal and regulatory requirements; developing, reviewing and monitoring the code of conduct applicable to employees and Directors; and
- reviewing the Company's compliance with the CG Code and disclosure in the corporate governance report.

During the Current Year and up to the date of this report, the Board has performed the corporate governance duties.

PRACTICE AND CONDUCT OF MEETINGS

Meeting schedules and draft agendas of each meeting are normally made available to Directors in advance. At least 14 days' notice will be given for a regular Board meeting to provide all Directors with an opportunity to attend and include matters in the agenda for a regular meeting. For other Board and committee meetings, reasonable notices are generally given. Board papers together with all appropriate, complete and reliable information are sent to all Directors at least 3 days before each Board meeting or Board committee meeting to ensure that they have sufficient time to review the papers and are adequately prepared for the meetings, and to keep the Directors apprised of the latest developments and financial position of the Group and to enable them to make informed decisions.

Minutes of all Board meetings recording sufficient details of matters considered and decisions reached are duly kept by the company secretary at the meetings and open for inspection by the Directors.

The Articles of Association contain provisions requiring Directors to abstain from voting and not to be counted in the quorum at meetings for approving transactions in which such Directors or any of their associates have a material interest.

MANAGEMENT FUNCTION

The Articles of Association set out matters which are specifically reserved to the Board for its decision. The management team meets together regularly to review and discuss with the executive Directors day-to-day operational issues, financial and operating performance as well as to monitor and ensure that the management is carrying out the directions and strategies set by the Board properly.

RELATIONSHIPS BETWEEN DIRECTORS

Mr. Wu Hao, the Chairman and an executive Director, is a cousin of Mr. Hu Yangjun, an executive Director. To the best knowledge of the Company, save as disclosed herein, during the Current Year, none of the other current Directors has or maintains any financial, business, family or other material, relevant relationship with any of the other Directors.

TRAINING AND SUPPORT OF DIRECTORS

Each newly appointed Director receives a formal, comprehensive and tailored induction on the first occasion of his/her appointment to ensure that he/she has a proper understanding of the Company's operations and business and is fully aware of his/her responsibilities under the relevant applicable Hong Kong laws, the Listing Rules, the SFO and other applicable regulations and the Company's business and governance policies.

All Directors have been given relevant guideline materials regarding the duties and responsibilities of being a Director, the relevant laws and regulations applicable to the Directors, duty of disclosure of interest and business of the Group and such induction materials will also be provided to newly appointed Directors shortly upon their appointment as Directors. All Directors have been updated on the latest developments regarding the Listing Rules and other applicable regulatory requirement(s) to ensure compliance and enhance their awareness of good corporate governance practices. There is a procedure agreed upon by the Board to ensure Directors, upon reasonable request, seek independent professional advice in appropriate circumstances, at the Company's expense.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

According to code provision C.2.1 of Part 2 of the CG Code, the roles of chairman and chief executive should be separated and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive should be clearly established to ensure a balance of power and authority.

During the year ended 31 March 2026, Mr. Wu Hao, the Chairman, was responsible for the leadership and effective running of the Board, ensuring that all material issues are discussed by the Board in a timely and constructive manner. Although the position of chief executive officer of the Company was vacant during the year, the day-to-day management responsibilities and the implementation of the Group's approved strategies were shared among the Executive Directors. As the roles of the Chairman and the day-to-day management functions were not performed solely by the same individual, the Board considers that a clear division of responsibilities and an effective balance of power and authority have been maintained. Therefore, the Company has complied with code provision C.2.1 of Part 2 of the CG Code throughout the year under review.

NON-EXECUTIVE DIRECTORS

The term of the appointment letters of all the non-executive Directors (including independent non-executive Directors) are for a fixed term or an initial term of one year and will be renewed automatically if no objection is raised by both parties. All Directors (including the executive Directors) are subject to retirement by rotation at least once every three years at the annual general meeting of the Company and are eligible for re-election pursuant to the Articles of Association.

FUNCTIONS, ROLES AND RESPONSIBILITIES OF THE BOARD

The Board is responsible for leadership and control of the Group and is collectively responsible for promoting the success of the Group by directing and supervising the Group's affairs. The Board focuses on formulating the Group's overall strategies, authorising the development plan and budget; monitoring financial and operating performance; reviewing the effectiveness of the internal control system; supervising and managing management's performance of the Group; and setting the Group's values and standards. The Board delegates the day-to-day management, administration and operation of the Group to the senior management. The delegated functions are reviewed by the Board periodically to ensure that they accommodate the needs of the Group. With delegated responsibility, the senior management is responsible for the day-to-day management, administration and operation of the Group, implementing the strategies and plans adopted by the Board and the Board committees and assumes full accountabilities to the Board for the operation of the Group. Both the Board and the senior management have clearly defined authorities and responsibilities under various risk management, internal control and check-and-balance mechanisms. The senior management should report back and obtain prior approval from the Board before making any significant decisions or entering into any significant commitments on the Company's behalf, and they may not exceed any authority given to them by resolutions of the Board or the Company.

The Board has set up three Board committees, namely the Audit Committee, the Remuneration Committee and the Nomination Committee for overseeing particular aspects of the Company's affairs. The Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances at the Company's expense.

The Company has arranged appropriate insurance cover for Directors' liabilities in respect of legal actions against them for corporate activities. The insurance coverage is reviewed on an annual basis.

AUDIT COMMITTEE

The Audit Committee has been established with written terms of reference setting out the duties, responsibilities and authorities delegated to them by the Board. The written terms of reference of the Audit Committee conform to the requirements laid down in the CG Code. As at the date of this report, the Audit Committee comprises three independent non-executive Directors, namely Mr. Jin Qingjun, Ms. Zhong Yingjie, Christina and Mr. Lan Yadong. Ms. Zhong Yingjie, Christina is the chairman of the Audit Committee and is also a certified public accountant in the PRC. She is experienced in the accounting and auditing field, and worked for the National Audit Office of the PRC.

The primary functions of the Audit Committee include reviewing the financial statements and reports and considering any significant or unusual items, reviewing the effectiveness of the Group's financial reporting processes and adequacy of the internal control system and the internal audit function, reviewing the risk management system and associated procedures, reviewing the scope and nature of the audit carried out by the Company's auditor. The Audit Committee meets at least twice a year to discuss any issues from the audit and any other matters the external auditor may wish to raise. The Audit Committee has reviewed the Group's annual results for the Current Year.

SUMMARY OF MATTERS RELATING TO THE 2023 SHARE OPTION SCHEME REVIEWED BY THE REMUNERATION COMMITTEE DURING THE CURRENT YEAR

A share option scheme (the “2023 Share Option Scheme”) was adopted in the annual general meeting held on 7 September 2023 (the “2023 AGM”), details of the principal terms of the 2023 Share Option Scheme are set out in the circular and the supplemental circular of the Company dated 21 July 2023 and 23 August 2023, respectively.

Vesting period and Performance target

The vesting period of the options granted under the 2023 Share Option Scheme to any participant shall not be less than 12 months. The Remuneration Committee is of the view that the discretion in allowing a shorter vesting period to the Employee Participant(s) in certain circumstances is appropriate and in line with market practice. Such discretion provides the Company with more flexibility in (i) providing higher incentives when attracting talents; (ii) rewarding exceptional performers with accelerated vesting; and/or (iii) granting option(s) in exceptional circumstances where justified, which is in line with the purpose of the 2023 Share Option Scheme.

The Remuneration Committee has also considered (a) the importance of the roles and responsibilities of the grantees; (b) the past performance and contributions of the grantees; and (c) the expected contributions of the grantees to be made to the future development of the Group and is of the view that the grant of share options without any performance target aligns with the purpose of the 2023 Share Option Scheme.

Clawback mechanism

There is no clawback mechanism attached to the share options. The share options granted shall lapse and cannot be exercised with immediate effect if the grantee, who is an employee (including any Director), ceases to be an employee or a director of the Group on the ground including, but without limitation to, that he or she has been guilty of serious misconduct.

In recommending the grant of share options to Directors and employees, the Remuneration Committee will take into account factors such as: (a) the purpose of the 2023 Share Option Scheme which is to recognise and acknowledge the contribution the Participants have made or may make to our Group as well as to provide motivation and optimise the performance and efficiency of such Participants; (b) the remuneration practice of the Group; (c) the duration of employment, remuneration package and contribution of the Participants; and (d) the prevailing market practice and industry wide comparison in order to enhance the competitiveness of the Group to retain talents and to provide incentives and motivation for the Participants to perform better.

The Remuneration Committee has noted that the purpose of the 2023 Share Option Scheme is to recognise and acknowledge the contributions or potential contributions made or to be made by the Participant(s) to the Group and that the 2023 Share Option Scheme does not restrictively specify the contribution. The Remuneration Committee has also considered (a) the importance of the roles and responsibilities of the Participants; (b) the past performance and contributions of the Participants; and (c) the expected contributions of the Participants to be made to the future development of the Group and is of the view that the grant of share options without any performance target aligns with the purpose of the 2023 Share Option Scheme.

The Remuneration Committee were of the view that no performance target and clawback mechanism being recommended and set for the grants were appropriate considering:

- (i) fulfilment of the purpose of the 2023 Share Option Scheme could be achieved without such requirements;
- (ii) the prevailing market practice at the time of the grant;
- (iii) the primary reason for the grants was to recognise the commitment, support and satisfactory performance of the Participants;
- (iv) the leadership, management and strategic business development provided by the executive Director; and
- (v) in line with the general practice of the Company to grant share options with shorter vesting period to Employee Participant(s) (as defined in the section headed “2023 Share Option Scheme” of the Report of the Directors) and without any performance target and clawback mechanism.

During the Current Year, no material matters relating to share schemes of the Company that were required to be reviewed or approved by the Remuneration Committee under Chapter 17 of the Listing Rules since there were no options granted under the 2023 Share Option Scheme.

The Board has adopted the Nomination Policy on the recommendation of the Nomination Committee, which sets out the criteria and process for the nomination and appointment of Directors of the Company. The Board considers that the Nomination Policy could ensure a balance of skills, experience and diversity of perspectives catered to the Company in the composition of the Board and continuity and appropriate leadership at the Board level. The Nomination Policy applies to the Directors of the Company and where applicable, senior management being groomed for Board positions pursuant to the succession planning of the Company.

The Board has delegated its responsibilities and authority for the selection and appointment of Directors to the Nomination Committee. Without prejudice to the authority and duties of the Nomination Committee as set out in its terms of reference, the ultimate responsibility for the selection and appointment of Directors of the Company rests with the entire Board.

In evaluating and selecting any candidate for directorship, the Nomination Committee will consider (i) character and integrity; (ii) qualifications including professional qualifications, skills, knowledge and experience and diversity aspects under the Board Diversity Policy that are relevant to the Company's business and corporate strategy; (iii) any measurable objectives adopted for achieving diversity on the Board; (iv) requirement for the Board to have independent Directors in accordance with the Listing Rules and whether the candidate would be considered independent with reference to the independence guidelines set out in the Listing Rules; (v) any potential contributions the candidate can bring to the Company and/or the Board in terms of qualifications and skills; (vi) experience, independence, gender and race diversity; (vii) willingness and ability to devote adequate time to discharge duties as a member of the Board and/or Board committee(s) of the Company; and (viii) such other perspectives that are appropriate to the Company's business and succession plan and where applicable, may be adopted and/or amended by the Board and/or the Nomination Committee from time to time for the nomination of Directors and succession planning.

The nomination process of selection and appointment of new Director

The Nomination Committee and/or the Board should, upon receipt of a proposal on the appointment of a new Director and the biographical information (or relevant details) of the candidate, evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship. If the process yields more than one desirable candidate, the Nomination Committee and/or the Board should rank them by order of preference based on the needs of the Company and the reference check on each candidate (where applicable). The Nomination Committee should then recommend that the Board to appoint the most appropriate candidate for directorship, as applicable. For any person that is nominated by a Shareholder for election as a Director at a general meeting of the Company, the Nomination Committee and/or the Board should evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship. Where appropriate, the Nomination Committee and/or the Board should make recommendations to the Shareholders with respect to the proposed election of Directors at a general meeting.

The nomination process of re-election of Director at general meeting

The Nomination Committee and/or the Board should review the overall contribution and service to the Company of each Director and his/her level of participation and performance on the Board. The Nomination Committee and/or the Board should also review and determine whether the Director continues to meet the criteria as set out above. The Nomination Committee and/or the Board should then make recommendations to the Shareholders in respect of the proposed re-election or replacement of Directors at a general meeting. Where the Board proposes a resolution to elect or re-elect a candidate as Director at a general meeting, the relevant information of the candidate will be disclosed in the circular to the Shareholders and/or the explanatory statement that accompanies the notice of the relevant general meeting in accordance with the Listing Rules and/or applicable laws and regulations.

The Nomination Committee has conducted regular reviews on the structure, size and composition of the Board and the Nomination Policy and considered that the current Nomination Policy complements the Company's corporate strategy and business needs. During the Current Year, the Nomination Committee considered the Nomination Policy and made recommendation to the Board on the appointment, re-appointment and re-designation of Director(s).

CORPORATE GOVERNANCE

The Board is also responsible for determining the policy for the corporate governance of the Company and performing the functions set out in code provision A.2.1 of Part 2 of the CG Code.

The Board has adopted the Board Diversity Policy setting out the approach to achieve diversity on the Board. The Company recognises and embraces the benefits of having a diverse Board to enhance the quality of its performance and to support the attainment of its strategic objectives and its sustainable development. In designing the Board's composition, Board diversity is considered from a range of perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. The Company will also take into account factors relating to its own business model and specific needs from time to time. The ultimate decision will be based on the merit and contribution that the selected candidates will bring to the Board.

As of the date of this report, the Board consists of one female Director and seven male Directors. With the Board members coming from a variety of business and/or industry bodies and/or professional and/or academic institutions and one out of the eight Board members being female, the Company considers that the Board possesses a balanced structure and a diverse mix of skills, experience and expertise appropriate to the requirements of the Company's business and development. Accordingly, the Board is satisfied with the gender diversity of the Board and intends to continue maintaining board diversity. The Board strives to ensure that it has the appropriate balance of skills, experience and diversity of perspectives that are required to support the execution of its business strategies in order for the Board to be effective. The Nomination Committee has been delegated the authority to review and assess the diversity of the Board, with the objective of maintaining a balance of skills, knowledge, experience and diversity of perspectives on the Board which are appropriate to the requirements of the Company's business. When identifying and selecting suitably qualified candidates for recommendation to the Board, the Nomination Committee will give consideration to the Board Diversity Policy whereby selection of candidates will be based on merit against objective criteria and with due regard to the benefits of diversity on the Board. The Nomination Committee will monitor the implementation of this policy and will from time to time review the Board Diversity Policy, as appropriate, to ensure the effectiveness of the Board Diversity Policy. The Nomination Committee will also discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval. The Board has reviewed the implementation and effectiveness of the Board Diversity Policy for the Current Year and considers it to be effective.

Based on the current composition of the Board and the background of the existing Directors, the Company is of the view that the Board has achieved gender diversity. Gender diversity at workforce levels (including our senior management) is disclosed in the Company's Environmental, Social and Governance report of the Company for the Current Year.

EMPLOYEE DIVERSITY

The Company also takes into account relevant factors in the recruitment and selection of key business management personnel and other personnel, and strives to maintain gender diversity. As at 31 March 2026, the gender ratio of all employees (including senior management) of the Company was 58.7% male and 41.3% female. Accordingly, the Company considers that gender diversity is also achieved in its workforce generally. We will continue to maintain gender diversity among all our staff and review our policies on employee recruitment and management in a timely manner in accordance with the Company's business development and needs.

DIVIDEND POLICY

The Board has adopted a dividend policy (the "Dividend Policy") that, in recommending or declaring dividends, the Company shall maintain adequate cash reserves for meeting the Group's working capital requirements and future growth as well as its Shareholder value.

The Board has the discretion to declare and distribute dividends to the Shareholders, subject to the Articles of Association and all applicable laws and regulations. The dividend payout ratio will vary from year to year. There is no assurance that a dividend will be proposed or declared in any particular amount in any given period. When considering the declaration and payment of dividends, the Board shall take into account (i) financial results; (ii) cash flow situation; (iii) business conditions and strategies; (iv) future operations and earnings; (v) capital requirements and expenditure plans; (vi) interests of the Shareholders; (vii) any restrictions on payment of dividends; and (viii) any other factors that the Board may consider relevant.

Depending on the financial conditions of the Group and the conditions and factors as set out above, dividends may be proposed and/or declared by the Board for a financial year or period as interim dividend, final dividend, special dividend and any distribution of net profits that the Board may deem appropriate. The Company in general meeting may from time to time declare dividends in any currency to be paid to the Shareholders but no dividends shall be declared in excess of the amount recommended by the Board subject to the Articles of Association and all applicable laws and regulations. The Company may declare and pay dividends by way of cash or scrip or by other means that the Board considers appropriate. Any dividend unclaimed shall be forfeited and shall revert to the Company in accordance with the Articles of Association. The Board will review the Dividend Policy as appropriate from time to time.

AUDITOR'S REMUNERATION

On 11 April 2025, Deloitte Touche Tohmatsu resigned as the external auditor of the Company. Prism Hong Kong Limited was appointed as the external auditor of the Company with effect from 11 April 2025 to fill the casual vacancy arising from the resignation of Deloitte Touche Tohmatsu. For details of the change of auditor, please refer to the announcement of the Company dated 11 April 2025 published on the website of the Stock Exchange.

COMPANY SECRETARY

Mr. Chow Chi Shing has been the company secretary of the Company since November 2015. Mr. Chow reports directly to the Board and/or the Chairman and is responsible to the Board for ensuring that the Board procedures, applicable laws, rules and regulations are followed and the Board activities are efficiently and effectively conducted. He is also responsible for ensuring that the Board is fully appraised of the relevant corporate governance developments relating to the Group and facilitating the induction and professional development of Directors. According to Rule 3.29 of the Listing Rules, Mr. Chow has taken no less than 15 hours of relevant professional training for the Current Year.

RESPONSIBILITIES IN RESPECT OF THE FINANCIAL STATEMENTS

The Directors are responsible for ensuring that the consolidated financial statements for each financial year are prepared to reflect a true and fair view of the state of affairs, profitability and cash flows of the Group in accordance with the disclosure requirements of the Listing Rules, Companies Ordinance (Chapter 622 of the Laws of Hong Kong) and the applicable accounting standards.

The Directors acknowledge their responsibilities for the preparation of the consolidated financial statements for the Current Year. The Directors confirm that, to the best of their knowledge, information and belief, having made all reasonable enquiries, they are not aware of any material uncertainties relative to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern. The statement issued by the external auditor of the Company regarding its reporting responsibilities was set out in detail in the Independent Auditor's Report on pages 59 to 63 of this annual report.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges that it is the responsibility of the Board for maintaining an adequate risk management and internal control system to safeguard Shareholders' investments and the Group's assets and review the effectiveness of such system on an annual basis. Such systems are designed to manage rather than eliminate the risks of failure to achieve business objectives, and could only provide reasonable but not absolute assurance against material misstatement or loss.

RISK MANAGEMENT ORGANISATIONAL STRUCTURE

Board

The Board is responsible for assessing and determining the nature and extent of risks that the Company is willing to accept for achieving the purposes, and procuring the Company to set up and maintain proper and effective risk management and internal control systems. With the assistance of the Audit Committee, whose authority has been delegated by the Board, the Board maintains constant monitoring of the risk management and internal control systems of the Group, as well as conducting reviews at least once a year as to its effectiveness.

Audit Committee

The Audit Committee is responsible for the risk management and internal control systems that provides advice and support to the Board in respect of all risk-related matters, including monitoring the implementation of the overall risk management procedures of the Group, conducting review of the risk register of the Group, reviewing and approving the internal control review plan and its results.

Management

The management of the Group is responsible for identifying and continuously monitoring the Group's exposure to risks in relation to strategy, operation, finance, reporting and compliance during the daily operations of the Group. It reports to the Board and the Audit Committee regarding the risks and their changes, formulates a set of internal control measures to mitigate the risks, collects through various channels the deficiencies of the internal control system and conducts rectifications in a timely manner.

Internal Audit Function

The Group has put in place the internal audit function. An annual review of the effectiveness of the risk management procedures of the Group will be conducted by the management and the Audit Committee, and professional internal control advisers may be consulted if necessary. The plan for internal control review will be submitted to the Audit Committee for review and approval, and the person in charge of the internal control review will also report the review results to the Audit Committee.

Risk Management Procedures

The Group has established a risk management framework, including the construction of the architecture for the aforementioned organisation and definition of the responsibilities of all parties concerned, and prepared risk management policies and processes and clarified the risk assessment procedures, which, specifically include risk identification, risk analysis, risk control and risk report.

- Step 1: Risk identification – identify current risks exposed to the Group and business and existing management and control measures therefore.
- Step 2: Risk analysis – analyse the possibility, extent of influence and existing management and control measures, identify risk exposure, and propose further countermeasures.
- Step 3: Risk control – implement and periodically detect the identified risks to ensure effective operation of risk countermeasures.
- Step 4: Risk report – summarise the results of risk management analysis, prepare action plans and report to the management, Audit Committee and the Board.

The Company would appoint an independent consultancy firm to conduct a thorough review of risk management and internal control systems of the Company and its subsidiaries on regular intervals basis when necessary. Such a review aims to examine key issues in relation to the accounting practices and all material controls, identify deficiencies and ineffective parts in the design and implementation of internal controls, and propose recommendations for improvement. With the assistance of the Audit Committee, the Board has reviewed and been aware of the effectiveness and sufficiency of the risk management and internal control systems of the Group. The Board, through the review of the systems of internal control and risk management by the Audit Committee, was not aware of any areas of concern that would have a material impact on the Group's financial position or result of operations, and considered that the Group's risk management and internal control systems were adequate and effective for the Current Year. The Group had complied with the applicable provisions on risk management and internal control as set out in the CG Code during the Current Year.

MAIN FEATURES OF RISK MANAGEMENT AND INTERNAL CONTROL SYSTEM

Maintaining an effective internal control system (Operational Level)

- Definite internal control policies and procedures are in place to enable clear segregation of responsibilities, authority and accountability of different departments and positions;
- A code of conduct has been formulated to promote integrity and ethical conducts to the staff;
- Whistleblowing system is set up to encourage employees to report any misconduct or fraud;
- Appropriate IT system access restrictions have been set to avoid disclosure of price-sensitive information;
- Policies regarding insider information disclosure are established, which involve reporting channels. The person in charge of the information disclosure will be responsible for answering external enquiries and seeking consultation from professional financial consultants or the Stock Exchange when necessary.

During the Current Year, the Board reviewed the effectiveness of the internal control policies and procedures, including the procedures regarding financial reporting and those as stipulated under the Listing Rules. When reviewing the risk management and internal control procedures, the Board had taken into consideration the adequacy of resources for accounting, internal audit and financial reporting, the qualifications and experience of the staff, training to be provided to the staff and the relevant budget.

Ongoing Monitoring of Risks (Risk Management Level)

Based on the risk management policies as formulated by the Board, the management will communicate with different operational departments and collect information on significant risk factors which will affect the Group in a bottom up approach and consistently monitor changes in risks. Risks which have been identified will be recorded in a risk register. Regular assessment will be carried out on the potential impact on the Group and the possibility of occurrence of each major risk so as to lay down relevant internal control measures.

The Company has procedures and internal controls for the handling of confidential information and dissemination of inside information. Control procedures have been implemented to ensure that unauthorised access and use of inside information are strictly prohibited. The Company also established procedures to facilitate employees of the Company to raise, in confidence, concerns about possible improprieties in financial reporting, internal control or other matters of the Company.

During the Current Year, the management reviewed risk management structure and procedures and submitted to the Board and the Audit Committee a risk assessment report and a 3-year plan of internal control review, so that the Board and the Audit Committee can enable effective monitoring of the Group's major risk and gain a better understanding of how the management handle and mitigate the risks.

Independent Review

The internal audit team of the Group is comprised of persons who are not responsible for areas under review. The list and scope of review have been approved by the Audit Committee. The team conducts an independent review of the risk management and internal control systems of the Group so as to assess the effectiveness. A report of internal control review is submitted to the Audit Committee.

During the Current Year, the internal audit team completed a review on internal control for the year, period of reviews covered transactions carried out from 1 April 2025 to 31 March 2026. The management had implemented rectifications and remediated internal control weaknesses identified. The internal audit team reported the review results to the Audit Committee.

Annual Review of System Effectiveness

The Board, through the Audit Committee, had conducted annual review of the effectiveness of the Group's risk management and internal control systems for the Current Year. The review covered all material controls, including financial, operational and compliance controls. The Audit Committee has received confirmation from management of the Group on the effectiveness of the systems. No significant areas of concern have been identified and the Board considered the systems effective and adequate.

During the annual review, the Audit Committee has also considered the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's internal audit, accounting and financial reporting functions, as well as those relating to Environmental, Social and Governance ("ESG") performance and reporting.

Handling and dissemination of inside information

The Group regulates the handling and dissemination of inside information according to the inside information policy of the Company and the "Guidelines on Disclosure of Inside Information" published by the SFC in June 2012 to ensure inside information remains confidential until the disclosure of such information is appropriately approved, and the dissemination of such information is efficiently and consistently made. The Company regularly reminds the Directors and employees about due compliance with all policies regarding the inside information. The Company also keeps Directors, senior management and employees apprised of the latest regulatory updates. The Company prepares or updates its guidelines or policies as appropriate to ensure the compliance with regulatory requirements from time to time.

WHISTLEBLOWING POLICY

The Company has adopted a whistleblowing policy (the "Whistleblowing Policy") to facilitate employees to raise concerns, in confidence, about possible improprieties in financial reporting, internal control or other matters. The Board shall review the Whistleblowing Policy regularly, conduct independent investigations on these matters if necessary, and consider and provide appropriate follow-up action.

ANTI-CORRUPTION POLICY

The Group adheres to the fairness and integrity principles for business operation and strictly abides by laws and regulations regarding anti-corruption. The Board has adopted an anti-corruption policy (the "Anti-Corruption Policy") which stipulate that employees are strictly forbidden to undertake any activity which conflicts or competes with the interests of the Group during employment. Employees are also required to make a declaration on any possible conflict of interest. During the Current Year, the Group had no concluded legal cases regarding corrupt practices. Trainings are also arranged for the Directors and employees to enhance their awareness of integrity and anti-corruption.

CHANGES IN CONSTITUTIONAL DOCUMENTS

There was no change to the memorandum and the articles of association of the Company during the Current Year.

COMMUNICATIONS WITH SHAREHOLDERS AND SHAREHOLDERS' RIGHTS

The Company treats all Shareholders equally and ensures that the Shareholders' rights are protected and that every convenience is provided to them, where practicable, to enable them to exercise their rights. The Company has adopted the Shareholders communication policy (the "Shareholders Communication Policy") and the procedures for Shareholders to propose a person for election as a Director to ensure that the Shareholders are provided with ready, equal and timely access to balanced and understandable information about the Company, to enable them to exercise their rights in an informed manner and to allow them to engage actively with the Company.

During the Current Year, the Board reviewed the implementation and effectiveness of the Shareholders Communication Policy. In conducting the review, the Board considered, among other things:

- whether the Company had maintained effective channels for Shareholders and the investment community to communicate their views to the Company;
- whether corporate communications, including annual reports, interim reports, announcements, circulars and notices of general meetings, were published in a timely manner on the websites of the Company and the Stock Exchange;
- whether Shareholders were provided with opportunities to attend general meetings, vote on resolutions and raise questions to the Board and/or the external auditor;
- whether enquiries from Shareholders and the investment community were handled and followed up appropriately;
- whether designated contact details, including the Company's principal office address and other contact channels, were made available to Shareholders for enquiries; and
- whether any material issues, complaints or feedback had been received from Shareholders regarding the effectiveness of communication with the Company.

Having considered the above matters, the Board was satisfied that the Shareholders Communication Policy had been properly implemented during the Current Year and remained effective.

The principles of the Shareholders Communication Policy are:

Shareholders' Enquiries

- Shareholders should direct their questions about their shareholdings to the Company's Hong Kong branch share registrar;
- Shareholders and the investment community may at any time make a request for the Company's information to the extent that such information is publicly available; and
- Shareholders and the investment community shall be provided with designated contacts, email addresses and enquiry lines of the Company in order to enable them to make any query in respect of the Company.

Corporate Communication

- corporate communications are published in plain language and in both English and Chinese versions on the Company's website and the Stock Exchange's website to facilitate the Shareholders' understanding; and
- Shareholders have the right to choose the language (either English or Chinese) or means of receipt of the corporate communication (in hard copy or through electronic means).

Corporate Website

- information on the Company's website (<http://www.475hk.com>) is updated on a regular basis; and
- information released by the Company to the Stock Exchange is also posted on the HKEX news website immediately thereafter. Such information includes financial statements, results announcements, circulars and notices of general meetings and associated explanatory documents, etc..

Shareholders' Meetings

- Shareholders are encouraged to participate in general meetings or to appoint proxies to attend and vote at meetings for and on their behalf if they are unable to attend the meetings;
- the process of the Company's general meeting will be monitored and reviewed on a regular basis, and, if necessary, changes will be made to ensure that Shareholders' needs are best served; and
- board members, in particular, the chairman of Board committees or their delegates, appropriate management executives and external auditors will attend annual general meetings to answer Shareholders' questions.

Shareholders' Rights to Convene an Extraordinary General Meeting

Under Article 58 of the Articles of Association, any one or more Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the company secretary of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two months after the deposit of such requisition. If within twenty-one days of such deposit the Board fails to proceed to convene such a meeting the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

Shareholders are welcome to suggest proposals relating to the operations, strategy and/or management of the Group to be discussed at Shareholders' meeting. Proposal shall be sent to the Board or the company secretary of the Company by written requisition. Pursuant to the Articles of Association, Shareholders who wish to put forward a proposal should convene an extraordinary general meeting by the procedures set out in the preceding paragraph.

Procedures for putting forward proposals at general meetings of the Company

Pursuant to Article 85 of the Articles of Association, no person, other than a Director retiring at the general meeting, shall, unless recommended by the Board for election, be eligible for election to the office of the Director at any general meeting, unless a notice in writing of the intention to propose a person for election as a Director signed by a Shareholder of the Company (other than the person to be proposed) and a notice in writing signed by that person of his willingness to be elected shall have been lodged at the Company's head office and principal place of business in Hong Kong at Room 2202, 22/F., Chinachem Century Tower, 178 Gloucester Road, Wanchai, Hong Kong. The period for lodgment of the notices will commence no earlier than the day after the despatch of the notice of the general meeting appointed for such election and end no later than seven days prior to the date of such general meeting and the minimum length of the period during which such notices to the Company may be given will be at least seven days.

If a Shareholder wishes to propose a person to stand for election as a Director, the biographical details of the person to be proposed as required by Rule 13.51(2) of the Listing Rules must also be lodged at the Company with the above written notices and the candidate should be evaluated by the Nomination Committee and the Board. The Company is required under Rule 13.73 of the Listing Rules to provide information about the proposal, which the Board considered appropriate, in a supplementary circular or by way of an announcement not later than ten business days before the general meeting. If the above notices are received by the Company less than twenty one days prior to the date of the general meeting, the Company may need to consider the adjournment of the general meeting.

Procedures for making enquiries to the Board

Shareholders are encouraged to maintain direct communication with the Company. Shareholders may send their enquiries requiring the Board's attention to the company secretary of the Company at the Company's principal office address at Room 2202, 22/F., Chinachem Century Tower, 178 Gloucester Road, Wanchai, Hong Kong.

INVESTOR RELATIONS

The Company endeavours to maintain good investor relationships with the Shareholders and potential investors by way of meeting them at annual general meetings and publishing interim and annual reports on the websites of the Company and the Stock Exchange.

The Company's website was set up as a means to provide information about the Company to the Shareholders and potential investors and to communicate with them directly and effectively. Shareholders are also encouraged to attend the Company's annual general meetings and general meetings for which notices are served for an adequate period in accordance with the provisions of the Listing Rules and the Articles of Association. The Directors are available to answer questions on the Group's business at the meetings.

REPORT OF THE DIRECTORS

The Directors are pleased to present their report together with the audited consolidated financial statements for the Current Year.

PRINCIPAL ACTIVITIES

The principal activity of the Company is investment holding, and its principal subsidiaries are principally engaged in energy and jewelry businesses in the PRC and Hong Kong. Details of the principal activities of the Company's subsidiaries are set out in note 39 to the consolidated financial statements. Details and respective analyses of the main segment information of the Group during the Current Year are set out in note 6 to the consolidated financial statements.

BUSINESS REVIEW

The business review of the Group for the Current Year and a review of the Group's future development are set out in the section "Management Discussion and Analysis" of this annual report.

ENVIRONMENTAL POLICY AND PERFORMANCE

The Group paid high attention to environmental protection and energy conservation to enhance the capacity of sustainable development and undertake relative social responsibility. The Group is committed to maximising energy conservation in its offices by promoting efficient use of resources such as lighting and air-conditioning systems and encouraging recycling of office supplies and other materials. The Group continually seeks to identify and manage energy efficiency opportunities in order to minimise environmental impacts attributable to its operational activities if possible.

ENVIRONMENTAL, SOCIAL AND GOVERNANCE REPORT

The Group strives to protect the environment and minimise any negative impact on the environment and occupational health and safety arising from its business, and to achieve the goal of sustainable development.

Pursuant to Rule 13.91 of the Listing Rules, an Environmental, Social and Governance ("ESG") report of the Company for the Current Year in compliance with the provisions set out in the ESG Reporting Code in Appendix C2 to the Listing Rules will be published on the Stock Exchange's website and the Company's website at the same time as the publication of the annual report of the Company.

COMPLIANCE WITH LAWS AND REGULATIONS

The Group recognises the importance of compliance with regulatory requirements and the risk of non-compliance with the relevant applicable rules and regulations. As far as the Board and management are aware, the Group has complied with all relevant laws and regulations in all material aspects which may have a significant impact on the business and operations of the Group during the Current Year.

PRINCIPAL RISKS AND UNCERTAINTIES FACED BY THE COMPANY

The Group's financial conditions, results of operations, and business prospects may be affected by a number of risks and uncertainties directly or indirectly pertaining to the Group's businesses. The following are the key risks and uncertainties identified by the Group. There may be other risks and uncertainties in addition to those shown below which are not known to the Group or which may not be material now but could turn out to be material in the future.

Risk of Economic Downturn

The business environment in the near future is challenging due to a number of factors such as uncertainty over the global economy, the escalated trade conflicts between the PRC and the United States and geopolitical risk. The adverse changes in the economic environment may result in reduced demand for our products, reduced selling price, order cancellations, lower revenue and margins and increased distribution costs. Therefore, the Group's management will refine and review business strategies based on its analysis of the macroeconomic changes, and consider business diversification so as to adapt to the overall economic change.

Risk of Regulatory Policies

The Chinese government is gradually intensifying requirements on energy conservation and environmental protection. While the Group's current operation complies with regulatory requirements, any future changes in relevant laws or regulations may have an impact on the operation and may increase expenses and costs. Therefore, policies which comply with relevant laws and regulations have been in place to minimise such risks. In addition, the Group has been maintaining close communication with government departments proactively to take measures timely in line with the industrial changes and the standards of policymaking.

Risk of Human Resources

There are fierce competitions in the industry and regions where the Group operates. Attributable to the experienced and skillful key personnel, including experienced management and technical engineers, the Group is able to maintain a competitive position. The incapability to attract sufficient key personnel or the outflow of skillful and experienced talents may impair the normal operation or quality of the Group, or even restrict its development. The Group is fully aware of such risks and endeavors to provide competitive remuneration packages as well as various incentive mechanisms to attract suitable talents while catering to the overall needs for cost-savings, in order to meet the requirement of corporate development. The Group will also review the employees' benefits regularly, and conduct manpower planning to replenish sufficient staff in time.

Financial Risks

The Group also faces financial risks in the ordinary course of business. A discussion of the principal financial risks, including operational risks and liquidity risks facing the Group are set out in the sections headed "Business Review", "Prospects" and "Liquidity and Financial Resources" in the "Management Discussion and Analysis" of this annual report. Details of financial risk management objectives and policies are set out in notes 32 and 33 to the consolidated financial statements.

RELATIONSHIP WITH EMPLOYEES, CUSTOMERS AND SUPPLIERS

The Company recognises that employees are our valuable assets. Thus, the Group provides a competitive remuneration package to attract and motivate the employees. The Group regularly reviews the remuneration package of employees and makes necessary adjustments to conform to the market standard.

The Group also understands that it is important to maintain good relationships with customers, suppliers and other business partners to achieve its long-term goals. Accordingly, the management will continue to ensure effective communication and develop mutually beneficial relationships with them. (3) Maximum number of Shares

The maximum number of Shares which may be issued upon exercise of all share options that could be granted under the 2016 Share Option Scheme and any other share option scheme adopted by the Company shall not in aggregate exceed 10% of the total number of issued Shares as at the date of adoption or subsequent date of refreshing such limit (i.e. 33,815,400 Shares based on 338,154,000 Shares in issue on 5 September 2019, representing 6.77% of the total number of issued Shares (excluding treasury shares) as at the date of this report). Unless with the prior approval of the Shareholders. There was no service provider sublimit adopted under the 2016 Share Option Scheme.

As at 1 April 2025 and 31 March 2026, the number of share options available for grant under the 2016 Share Option Scheme were nil as the 2016 Share Option Scheme was terminated with effect from the conclusion of the 2023 AGM.

(4) Maximum entitlement of each 2016 Scheme Eligible Participant

The maximum number of Shares issued and to be issued upon exercise of the options granted to each participant under the 2016 Share Option Scheme and any other share option scheme adopted by the Company in any 12-month period must not exceed 1% of the Shares in issue as at the date of grant unless otherwise approved by the Shareholders.

(5) Exercise period

The period during which the share options granted can be exercised is to be determined and notified by the Directors to the grantee provided that such period shall not be more than ten years from the date of offer of such share options.

(6) Performance target and clawback mechanism

Subject to the terms of the 2016 Share Option Scheme, there was no minimum period for which an option granted must be held before it can be exercised. There was no performance targets required to be achieved by the grantees before exercising the share options, and there was no clawback mechanism attached to the share options under the 2016 Share Option Scheme.

(7) Vesting period

There was no specific vesting period for the options granted prescribed in the 2016 Share Option Scheme. In respect of any particular option, the options can be vested at any time after the expiry of a period which may be determined by the Board from the date of grant of the relevant option.

(8) Amount payable on acceptance of option offer

Options granted must be taken up by the 2016 Scheme Eligible Participant within 28 days from the date of offer, upon payment of HK\$10 by way of consideration for the grant.

(9) Basis of determining the exercise price

The exercise price per Share under the 2016 Share Option Scheme is determined by the Board and notified to the 2016 Scheme Eligible Participant at the time the grant of the options is made to (and subject to acceptance by) the 2016 Scheme Eligible Participant and will be at least the highest of: (a) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheets on the date of the grant (subject to acceptance) of the option, which must be a business day; (b) the average closing price of the Shares as stated in the Stock Exchange's daily quotations sheets for the five business days immediately preceding the date of the grant (subject to acceptance) of the option; and (c) the nominal value of the Shares.

(10) Termination of the 2016 Share Option Scheme

The 2016 Share Option Scheme had a life of 10 years and was terminated on 7 September 2023 at the 2023 AGM. No further options will be or have been granted under the 2016 Share Option Scheme after its termination. In respect of all options which remained exercisable on such date, the provisions of the 2016 Share Option Scheme remained in full force and effect.

2023 SHARE OPTION SCHEME

A summary of the principal terms of the 2023 Share Option Scheme is set out as follows:

(1) Purpose of the 2023 Share Option Scheme

The purpose of the 2023 Share Option Scheme is to recognise and acknowledge the contributions or potential contributions made or to be made by the 2023 Scheme Eligible Participants (as defined below) to the Group and/or, to motivate the 2023 Scheme Eligible Participants to optimise their performance and efficiency for the benefit of the Group, and to maintain or attract business relationships with the 2023 Scheme Eligible Participants whose contributions are or may be beneficial to the growth of the Group.

(2) Participants of the 2023 Share Option Scheme

The participants of the 2023 Share Option Scheme include any employee and any Director (including executive, non-executive and independent non-executive Directors) (both collectively, the "Employee Participant(s)") and any employees and the directors of the holding companies, fellow subsidiaries or associated companies of the Company (both collectively, the "Related Entity Participant(s)") (the "2023 Scheme Eligible Participant").

(3) Maximum number of Shares

The maximum number of Shares which may be issued upon exercise of all share options granted and to be granted under the 2023 Share Option Scheme and any other schemes adopted by the Company must not in aggregate exceed 10% of the total number of issued Shares as at the Adoption Date (the "Scheme Mandate Limit") (i.e. 38,756,400 Shares based on 387,564,000 Shares in issue on the Adoption Date, representing 7.76% of the total number of issued Shares (excluding treasury shares) as at the date of this report). Unless approval has been obtained from the Shareholders. There was no service provider sublimit adopted under the 2023 Share Option Scheme.

No share option has been granted under the 2023 Share Option Scheme since the Adoption Date and as at the date of this report.

(4) Maximum entitlement of each 2023 Scheme Eligible Participant

The maximum number of Shares issued and to be issued upon exercise of the options granted to each participant under the 2023 Share Option Scheme and any other share option scheme adopted by the Company in any 12-month period must not exceed 1% of the Shares in issue (excluding treasury shares) as at the date of grant unless otherwise approved by the Shareholders.

Where any grant of options to a substantial Shareholder, an independent non-executive Director, or any of their respective associates would result in the Shares issued and to be issued upon exercise of all options already granted and to be granted to such person in any 12-month period up to and including the date of the grant representing in aggregate over 0.1% of the total number of Shares in issue (excluding treasury shares) then such grant of options shall be subject to prior approval of the Shareholders who are not the grantee, his/her associates, or any connected person of the Company as defined in the Listing Rules.

(5) Exercise period

The period during which the share options granted can be exercised is to be determined and notified by the Directors to the grantee provided that such period shall not be more than ten years from the date of offer of such share options.

(6) Performance target and clawback mechanism

Subject to the terms of the 2023 Share Option Scheme, there is no minimum period for which an option granted must be held before it can be exercised. There are no performance targets required to be achieved by the grantees before exercising the share options, and there is no clawback mechanism attached to the share options under the 2023 Share Option Scheme.

(7) Vesting period

Under the 2023 Share Option Scheme, the vesting period of the options granted to any 2023 Scheme Eligible Participant shall not be less than 12 months, unless otherwise determined by the Board and prescribed in the 2023 Share Option Scheme.

(8) Amount payable on acceptance of Share Option offer

HK\$10.00 is payable by the 2023 Scheme Eligible Participant to the Company upon acceptance of the share option offered as consideration for the grant.

(9) Basis of determining the exercise price

The exercise price per Share under the 2023 Share Option Scheme is determined by the Board and notified to the 2023 Scheme Eligible Participant at the time the grant of the options is made to (and subject to acceptance by) the 2023 Scheme Eligible Participant and will be at least the highest of: (a) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheets on the date of the grant (subject to acceptance) of the option, which must be a business day; (b) the average closing price of the Shares as stated in the Stock Exchange's daily quotations sheets for the five business days immediately preceding the date of the grant (subject to acceptance) of the option; and (c) the nominal value of the Shares.

(10) Remaining life of the 2023 Share Option Scheme

The 2023 Share Option Scheme has a life of 10 years and will remain valid until 7 September 2033 after which no further share options shall be granted or accepted under the 2023 Share Option Scheme. However, the provisions of the 2023 Share Option Scheme shall in all other respects remain in full force and effect. The remaining life of the 2023 Share Option Scheme is approximately 7 years.

CONVERTIBLE BONDS

On 5 December 2022, the Company issued the 3-year Convertible Bonds in the aggregate principal amount of HK\$52,000,000 with 0% interest per annum to Mr. Zhang Bing, an executive Director, which upon exercise of the conversion rights attached to the Convertible Bonds in full, the Convertible Bonds were convertible into 70,270,270 Shares at a conversion price of HK\$0.74 per conversion share (subject to adjustment).

As disclosed in the “Disposal of 35% Equity Interest in an Associate, Chengdu Huahan” in the “Management Discussion and Analysis” of this report, the conditions for maintaining the investment were not met, triggering the Cancellation and Re-Transfer Arrangement. Accordingly, the Convertible Bonds were automatically cancelled in full on 1 December 2025.

Save as disclosed above, there were no other convertible bonds issued by the Company during the Current Year.

6. 100% of the entire issued share capital of Oceanic Capital is owned by Mr. Hu Yangjun. Mr. Hu Yangjun is deemed to be interested in all the Shares in which Oceanic Capital is interested by virtue of the SFO.

OPINION

We have audited the consolidated financial statements of Central Development Holdings Limited (the “Company”) and its subsidiaries (collectively referred to as the “Group”) set out on pages 64 to 153, which comprise the consolidated statement of financial position as at 31 March 2026, and the consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information and other explanatory information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 March 2026, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with HKFRS Accounting Standards issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”) and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing (“HKSAs”) issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with the HKICPA’s Code of Ethics for Professional Accountants (the “Code”), as applicable to audits of financial statements of public interest entities. We have also fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

KEY AUDIT MATTER

A key audit matter is the matter that, in our professional judgment, was of most significance in our audit of the consolidated financial statements of the current period. This matter was addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on this matter.

Key audit matter

How our audit addressed the key audit matter

Valuation of investment properties

We identified the valuation of investment properties as a key audit matter due to the inherent level of subjective judgments and estimates required in determining the fair values.

The Group's investment properties represent certain portion of the Group's factory being leased, and are stated at fair value of HK\$76,328,000, as at 31 March 2026 with loss on fair value changes of HK\$556,000 recognised in the consolidated statement of profit or loss and other comprehensive income for the year then ended.

The Group's investment properties are measured using the fair value model based on a valuation performed by an independent qualified professional valuer (the "Valuer"). Details of the valuation techniques and key inputs used in the valuations are disclosed in note 17 to the consolidated financial statements.

Our procedures in relation to the valuation of investment properties included:

- Evaluating the competence, capabilities, and objectivity of the Valuer and obtaining an understanding of the Valuer's scope of work and their terms of engagement;
- Evaluating the appropriateness of the Valuer's valuation approaches to assess if they meet the requirements of the HKFRS Accounting Standards;
- Challenging the reasonableness of the key assumptions applied based on available market data; and
- Obtaining the detailed work of the Valuer on valuation of the investment properties to evaluate the accuracy and relevance of key data inputs underpinning the valuation, such as rental income, term of existing leases by comparing them to the existing leases summary of the Group or reversionary income potential by comparing fair market rents estimated by the Valuer against comparable market transactions and evaluating whether capitalisation rates adopted are comparable to the market.

OTHER INFORMATION

The directors of the Company are responsible for the other information. The other information comprises the information included in the annual report, but does not include the consolidated financial statements and our auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

RESPONSIBILITIES OF DIRECTORS AND THOSE CHARGED WITH GOVERNANCE FOR THE CONSOLIDATED FINANCIAL STATEMENTS

The directors of the Company are responsible for the preparation of the consolidated financial statements that give a true and fair view in accordance with HKFRS Accounting Standards issued by the HKICPA and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the directors of the Company determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the directors of the Company are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Group or to cease operations, or have no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Group's financial reporting process.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Group to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosures, and whether the consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
- Plan and perform the group audit to obtain sufficient appropriate audit evidence regarding the financial information of the entities or business units within the Group as a basis for forming an opinion on the group financial statements. We are responsible for the direction, supervision and review of the audit work performed for purposes of the group audit. We remain solely responsible for our audit opinion.

NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

For the year ended 31 March 2026

1. GENERAL INFORMATION

The Company is a public limited liability company incorporated in the Cayman Islands as an exempted company and its shares are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). Its parent and ultimate holding company is Resources Rich Capital Limited, a company incorporated in the British Virgin Islands. The address of the registered office of the Company is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The address of the principal place of business of the Company is Room 2202, 22/F., Chinachem Century Tower, 178 Gloucester Road, Wanchai, Hong Kong.

The Company is an investment holding company. Its subsidiaries are principally engaged in jewelry and energy businesses in the People’s Republic of China (“PRC”) and Hong Kong (“HK”). The Company and its subsidiaries are collectively referred to as the “Group”. Details of the principal subsidiaries of the Company are set out in note 39.

The functional currency of the Company is Renminbi (“RMB”). The consolidated financial statements are presented in Hong Kong dollars (“HK\$”), as the Company’s shares are listed on the Stock Exchange, the directors of the Company consider that it is appropriate to present the consolidated financial statements in HK\$.

Except for the new HKFRS Accounting Standard mentioned below, the directors of the Company anticipate that the application of all other new and amendments to HKFRS Accounting Standards will have no material impact on the consolidated financial statements in the foreseeable future.

HKFRS 18 Presentation and Disclosure in Financial Statements

HKFRS 18 *Presentation and Disclosure in Financial Statements*, which sets out requirements on presentation and disclosures in financial statements, will replace HKAS 1 *Presentation of Financial Statements*. This new HKFRS Accounting Standard, while carrying forward many of the requirements in HKAS 1, introduces new requirements to present specified categories and defined subtotals in the statement of profit or loss; provide disclosures on management-defined performance measures in the notes to the financial statements and improve aggregation and disaggregation of information to be disclosed in the financial statements. In addition, some HKAS 1 paragraphs have been moved to HKAS 8 and HKFRS 7. Minor amendments to HKAS 7 *Statement of Cash Flows* and HKAS 33 *Earnings per Share* are also made.

HKFRS 18, and amendments to other standards, will be effective for annual periods beginning on or after 1 January 2027, with early application permitted. The application of the new standard is expected to affect the presentation of the statement of profit or loss and disclosures in the future financial statements. The Group is in the process of assessing the detailed impact of HKFRS 18 on the Group's consolidated financial statements.

3. BASIS OF PREPARATION OF CONSOLIDATED FINANCIAL STATEMENTS AND MATERIAL ACCOUNTING POLICY INFORMATION

3.1 Basis of preparation of consolidated financial statements

The consolidated financial statements have been prepared in accordance with HKFRS Accounting Standards issued by the HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for investment properties and derivative financial instruments in relation to convertible bonds that are measured at fair value as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 “Share-based Payment”, leasing transactions that are accounted for in accordance with HKFRS 16 “Leases”, and measurements that have some similarities to fair value but are not fair value, such as net realisable value for the purposes of measuring inventories in HKAS 2 “Inventories” or value in use for the purpose of impairment assessment in HKAS 36 “Impairment of Assets” (“HKAS 36”).

A fair value measurement of a non-financial asset takes into account a market participant’s ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For financial instruments and investment properties which are transacted at fair value and a valuation technique that unobservable inputs are to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

Basis of consolidation (Continued)

Profit or loss and each item of other comprehensive income is attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Changes in the Group's interests in existing subsidiaries

Changes in the Group's interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the non-controlling interests' proportionate interests.

Any difference between the amount by which the non-controlling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

Changes in the Group's interests in existing subsidiaries (Continued)

When the Group loses control of a subsidiary, the assets and liabilities of that subsidiary and non-controlling interests (if any) are derecognised. A gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary attributable to the owners of the Company. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRS Accounting Standards). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKFRS 9 Financial Instruments or, when applicable, the cost on initial recognition of an investment in an associate or a joint venture.

Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

Principal versus agent

When another party is involved in providing goods or services to a customer, the Group determines whether the nature of its promise is a performance obligation to provide the specified goods or services itself (i.e. the Group is a principal) or to arrange for those goods or services to be provided by the other party (i.e. the Group is an agent).

The Group is a principal if it controls the specified good or service before that good or service is transferred to a customer.

Principal versus agent (Continued)

The Group is an agent if its performance obligation is to arrange for the provision of the specified good or service by another party. In this case, the Group does not control the specified good or service provided by another party before that good or service is transferred to the customer. When the Group acts as an agent, it recognises revenue in the amount of any fee or commission to which it expects to be entitled in exchange for arranging for the specified goods or services to be provided by the other party.

Investment properties

Investment properties are properties held to earn rentals and/or for capital appreciation.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at fair value, adjusted to exclude any prepaid or accrued operating lease income.

Gains or losses arising from changes in the fair value of investment properties are included in profit or loss for the period in which they arise.

Intangible assets

Intangible assets acquired in an assets acquisition and are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets acquired in asset acquisitions with finite useful lives are reported at costs less accumulated amortisation and any accumulated impairment losses. Amortisation for intangible assets with finite useful lives is recognised on a straight-line basis over their estimated useful lives. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains and losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in profit or loss when the asset is derecognised.

Leases

Definition of a lease

The Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception of the contract. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

The Group as a lessee

The Group applies the short-term lease recognition exemption to leases of offices that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. It also applies the recognition exemption for leases of low-value assets to leases of office equipment and laptop computers that are considered to be of low value. Lease payments on short-term leases and leases of low-value assets are recognised as an operating expense on a straight-line basis over the lease term.

Right-of-use assets

The cost of right-of-use assets includes:

- the amounts of the initial measurement of the lease liabilities;
- any lease payments made at or before the commencement date, less any lease incentives received;
- any initial direct costs incurred by the Group; and
- an estimate of costs to be incurred by the Group in dismantling and removing the underlying assets, restoring the site on which it is located or restoring the underlying asset to the condition required by the terms and conditions of the lease.

Except for those that are classified as investment properties and measured under fair value model, right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

Refundable rental deposits

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

Lease liabilities

At the commencement date of a lease, the Group recognises and measures the lease liability at the present value of lease payments that are unpaid at that date. In calculating the present value of lease payments, the Group uses the incremental borrowing rate at the lease commencement date if the interest rate implicit in the lease is not readily determinable.

The lease payments include:

- fixed payments (including in-substance fixed payments) less any lease incentives receivable;
- variable lease payments that depend on an index or a rate, initially measured using the index or rate as at the commencement date;
- amounts expected to be payable by the Group under residual value guarantees;
- the exercise price of a purchase option if the Group is reasonably certain to exercise the option; and
- payments of penalties for terminating a lease, if the lease term reflects the Group exercising an option to terminate the lease.

After the commencement date, lease liabilities are adjusted by interest accretion and lease payments.

The Group presents lease liabilities as a separate line item on the consolidated statement of financial position.

The Group as a lessor

Classification and measurement of leases

Leases for which the Group is a lessor are classified as operating leases. Whenever the terms of the lease transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee, the contract is classified as a finance lease. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease.

Refundable rental deposit

Refundable rental deposits received are accounted for under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments from lessees.

Interests in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

Interests in associates (Continued)

An investment in an associate is accounted for using the equity method from the date on which the investee becomes an associate. On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The Group assesses whether there is objective evidence that the interest in an associate may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised is not allocated to any asset, including goodwill, that forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When the Group ceases to have significant influence over an associate, it is accounted for as a disposal of the entire interest in the investee with a resulting gain or loss being recognised in profit or loss. When the Group retains an interest in the former associate and the retained interest is a financial asset within the scope of HKFRS 9, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition. The difference between the carrying amount of the associate and the fair value of any retained interest and any proceeds from disposing of the relevant interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal/partial disposal of the relevant associate.

Property, plant and equipment

Property, plant and equipment including buildings are tangible assets that are held for use in the production or supply of goods or services, or administrative purposes. Property, plant and equipment are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition. To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land is presented as “right-of-use assets” in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

If a property becomes an investment property because its use has changed as evidenced by end of owner-occupation, any difference between the carrying amount and the fair value of that item (including the relevant leasehold land classified as right-of-use assets) at the date of transfer is recognised in other comprehensive income and accumulated in property revaluation reserve. On the subsequent sale or retirement of the property, the relevant revaluation reserve will be transferred directly to accumulated losses.

Impairment on property, plant and equipment, right-of-use assets and intangible assets

At the end of the reporting period, the Group reviews the carrying amounts of its property, plant and equipment, right-of-use assets and intangible assets with finite useful lives to determine whether there is any indication that these assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss (if any).

The recoverable amount of property, plant and equipment, right-of-use assets and intangible assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cash-generating unit ("CGU") to which the asset belongs.

In testing a CGU for impairment, corporate assets are allocated to the relevant CGU when a reasonable and consistent basis of allocation can be established, or otherwise they are allocated to the smallest group of CGUs for which a reasonable and consistent allocation basis can be established. The recoverable amount is determined for the CGU or group of CGUs to which the corporate asset belongs, and is compared with the carrying amount of the relevant CGU or group of CGUs.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a CGU) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a CGU) is estimated to be less than its carrying amount, the carrying amount of the asset (or a CGU) is reduced to its recoverable amount. For corporate assets or portion of corporate assets which cannot be allocated on a reasonable and consistent basis to a CGU, the Group compares the carrying amount of a group of CGUs, including the carrying amounts of the corporate assets or portion of corporate assets allocated to that group of CGUs, with the recoverable amount of the group of CGUs. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of CGUs. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit or the group of CGUs. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or CGU or a group of CGUs) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a CGU or a group of CGUs) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purpose of presenting the consolidated financial statements, the assets and liabilities of the Group's operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the date of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in a joint arrangement or an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

Exchange differences relating to the retranslation of the Group's net assets in RMB to the Group's presentation currency (i.e. HK\$) are recognised directly in other comprehensive income and accumulated in exchange reserve. Such exchange differences accumulated in the exchange reserve are not reclassified to profit or loss subsequently.

Retirement benefit costs

Payments to defined contribution retirement benefit plans are recognised as an expense when employees have rendered service entitling them to the contributions. Payments made to state-managed retirement benefit schemes are dealt with as payments to defined contributions plans where the Group's obligations under the schemes are equivalent to those arising in a defined contribution retirement benefit plan.

Short-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. All short-term employee benefits are recognised as an expense unless another HKFRS Accounting Standards requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries) after deducting any amount already paid.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from loss before taxation because of income or expense that are taxable or deductible in other years and that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liabilities are settled or the asset is realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 “Income Taxes” (“HKAS 12”) requirements to the leasing transaction as a whole. Temporary differences relating to right-of-use assets and lease liabilities are assessed on a net basis. Excess of depreciation on right-of-use assets over the lease payments for the principal portion of lease liabilities resulting in net deductible temporary differences.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxable entity by the same taxation authority.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost of inventories are determined on a first-in, first-out method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale. Costs necessary to make the sale include incremental costs directly attributable to the sale and non-incremental costs which the Group must incur to make the sale.

Cash and cash equivalents

Cash and cash equivalents presented on the consolidated statement of financial position and consolidated statement of cash flows include cash, which comprises cash on hand and demand deposits; and cash equivalents, which comprises short-term (generally with original maturity of three months or less), highly liquid investments that are readily convertible to a known amount of cash and which are subject to an insignificant risk of changes in value. Cash equivalents are held for the purpose of meeting short-term cash commitments rather than for investment or other purposes.

Financial instruments

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15 “Revenue from Contracts with Customers” (“HKFRS 15”).

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

All recognised financial assets at initial recognition, as subsequently measured in their entirety at amortised cost, depending on their classification.

The classification of financial assets at initial recognition depends on the financial asset’s contractual cash flow characteristics and the Group’s business model for managing them.

Classification and subsequent measurement of financial assets

Financial assets that meet the following conditions are subsequently measured at amortised cost:

- the financial asset is held within a business model whose objective is to collect contractual cash flows; and
- the contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairments.

Amortised cost and interest income

Interest income is recognised using the effective interest method for financial assets measured subsequently at amortised cost. Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset, except for financial assets that have subsequently become credit-impaired.

The Group performs impairment assessment under expected credit loss (“ECL”) model on financial assets (including trade receivables, other receivables, deposits and bank balances) which are subject to impairment assessment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL (“12m ECL”) represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessments are done based on the Group’s historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables. The ECL on trade receivables are assessed individually.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

The Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

Definition of default

The Group considers an event of default occur when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

The Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider; or
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation

Write-off policy

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data and forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Derecognition of financial assets

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity.

On derecognition of a financial asset measured at amortised cost, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

Financial liabilities and equity

Classification as debt or equity

Debt and equity instruments are classified as either financial liabilities or equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received, net of direct issue costs.

Financial liabilities at amortised cost

Financial liabilities, including trade payables, other payables, bank borrowing, convertible bonds and loans from a shareholder and a controlling shareholder are subsequently measured at amortised cost, using the effective interest method.

Convertible bonds

A conversion option that will be settled other than by the exchange of a fixed amount of cash or another financial asset for a fixed number of the Group's own equity instruments is a conversion option derivative.

At the date of issue, both the debt and derivative components (derivative financial instruments) are recognised at fair value. In subsequent periods, the debt component of the convertible bonds is carried at amortised cost using the effective interest method. The derivative financial instruments are measured at fair value with changes in fair value recognised in profit or loss.

Transaction costs that relate to the issue of convertible bonds are allocated to the debt and derivative components in proportion to their relative fair values. Transaction costs relating to the derivative component are charged to profit or loss immediately. Transaction costs relating to the debt component are included in the carrying amount of the debt portion and amortised over the period of the convertible bonds using the effective interest method.

Derecognition/modification of financial liabilities

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

When the contractual terms of financial liabilities are modified, such as extending the tenure, the revised terms would result in a substantial modification from the original terms, after taking into account all relevant facts and circumstances including qualitative factors, such modification is accounted for as derecognition of the original financial liability and the recognition of new financial liability. The difference between the carrying amount of financial liability derecognised and the fair value of consideration paid or payable is recognised in profit or loss.

Derivative financial instruments

Derivatives are initially recognised at fair value at the date when derivative contracts are entered into and are subsequently remeasured to their fair value at the end of the reporting period. The resulting gain or loss is recognised in profit or loss.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

Any specific borrowing that remains outstanding after the related asset is ready for its intended use or sale is included in the general borrowing pool for calculation of capitalisation rate on general borrowings. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Equity-settled share-based payment transaction

Share options granted to employees and others providing similar services

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date.

The fair value of the equity-settled share-based payments determined at the grant date without taking into consideration of all non-market vesting conditions is expensed on a straight-line basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity (share options reserve).

At the end of the reporting period, the Group revises its estimate of the number of equity instruments expected to vest based on an assessment of all relevant non-market vesting conditions. The impact of the revision of the original estimates during the vesting period, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share options reserve. For share options that vest immediately at the date of grant, the fair value of the share options granted is expensed immediately to profit or loss.

When share options are exercised, the amount previously recognised in the share options reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in the share options reserve will be transferred to accumulated losses.

4. CRITICAL ACCOUNTING JUDGMENT AND KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 3.2, the directors of the Company are required to make judgments, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgment in applying accounting policies

The following is the critical judgment that the directors of the Company have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

Deferred taxation on investment properties

For the purposes of measuring deferred taxation arising from investment properties that are measured using the fair value model, the directors of the Company have reviewed the Group's investment properties and concluded that the Group's investment properties are held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Therefore, in measuring the Group's deferred taxation on investment properties, the directors of the Company have determined that the presumption that the carrying amounts of investment properties measured using the fair value model are recovered entirely through sale is rebutted. Accordingly, deferred taxation in relation to the Group's investment properties has been measured based on the tax consequences of recovering the carrying amounts entirely through use.

Key sources of estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Fair value of investment properties

At the end of the reporting period, the Group's investment properties are stated at fair value of HK\$76,328,000 (2025: HK\$73,573,000) based on the valuation performed by an independent qualified professional valuer. In determining the fair value, the valuer has applied income approach which involves, inter-alia, significant unobservable inputs and significant judgment, representing market rent and capitalisation rate. In relying on the valuation, the management of the Group has exercised their judgment and is satisfied that the method of valuation is reflective of the current market conditions.

Key sources of estimation uncertainty (Continued)

Fair value of derivative financial instruments in relation to convertible bonds

The Group's convertible bonds and related derivative financial instruments were fully cancelled and derecognised during the year. While outstanding, their fair values were determined by an independent qualified professional valuer using a binomial option pricing model, which involves, inter-alia, estimates of certain unobservable inputs (e.g. option-adjusted spread, stock price volatility), and the fair values were sensitive to these estimates. The fair value of these instruments as at 31 March 2025 was HK\$2,137,000. As at the end of the reporting period, the Group holds no such instruments. The information about these instruments is disclosed in notes 28 and 33.

Assessment of ECL for trade and other receivables

Trade and other receivables are assessed for ECL individually and the management of the Group assesses and applies internal credit rating for its customers individually by reference to their historical default rates taking into consideration reasonable and supportable forward-looking information that is available without undue costs or effort.

The ECL is sensitive to changes in estimates. The information about the ECL and the Group's trade and other receivables are disclosed in notes 33 and 21, respectively.

Impairment assessment of property, plant and equipment, right-of-use assets and intangible assets

Property, plant and equipment, right-of-use assets and intangible assets are stated at costs less accumulated depreciation/amortisation and impairment, if any. In determining whether an asset is impaired, the Group has to exercise judgment and make estimation, particularly in assessing: (1) whether an event has occurred or any indicators that may affect the asset value; (2) whether the carrying value of an asset can be supported by the recoverable amount, in the case of value in use, the net present value of future cash flows which are estimated based upon the continued use of the asset; and (3) the appropriate key assumptions to be applied in estimating the recoverable amounts including cash flow projections and an appropriate discount rate.

When it is not possible to estimate the recoverable amount of an individual asset (including right-of-use assets), the Group estimates the recoverable amount of the CGU to which the assets belong, including allocation of corporate assets when a reasonable and consistent basis of allocation can be established, otherwise recoverable amount is determined at the smallest group of cash generating units, for which the relevant corporate assets have been allocated. Changing the assumptions and estimates, including the discount rates, the growth rate and budgeted gross margin in the cash flow projections, could materially affect the recoverable amounts.

(a) Sales of jewelry products, solar energy products and LNG

The Group recognises revenue from the sales of jewelry products, solar energy products and LNG when the performance obligations are satisfied which refers to delivery of goods to the customers, at this point, the Group has no unfulfilled obligation that could affect the customers' acceptance of the products. Performance obligations are satisfied at a point in time once control of the goods has been transferred to the customers. The customers have obtained control on the goods through their ability to direct the use of and obtain substantially all the benefits from the goods, and, at the same time, the customers have accepted the risks of obsolescence and loss of the products. Revenue from sales of jewelry products, solar energy products and LNG is recognised based on the price specified in the contracts with customers. No element of financing is deemed present as the sales are made with an average credit term of 5 to 365 days.

The Group has no particular policy on the amounts received prior to the delivery of jewelry, solar energy products and LNG and it is negotiated with customers on contract-by-contract basis. The advance payments received from customers are recognised as contract liabilities throughout the period before the control of the goods is transferred to customers.

(b) Sales of refined oil

The Group recognised revenue from sales of refined oil when control of refined oil has transferred, being at the point the customer purchases the refined oil at filling station. Payment of the transaction price is due immediately at the point the customer purchases the goods.

(iii) Transaction price allocated to the remaining performance obligation for contracts with customers

All transactions in respect of sales of goods and provision of services take place within a year and, thus, the transaction prices allocated to the unsatisfied contracts are not disclosed according to the practical expedient of HKFRS 15.

Segment results represent the profit or loss by each segment without allocation of gain or loss on fair value changes of investment properties and derivative financial instruments, gain on disposal of interest in an associate, unallocated corporate expenses which include central administration costs, directors’ remuneration at the head office, unallocated corporate income which include rental income, interest income and certain sundry income and unallocated finance costs which include certain interest on lease liabilities, interest on convertible bonds, imputed interest and interest on loans from a shareholder and a controlling shareholder. This is the measure reported to the CODM for the purposes of resource allocation and performance assessment.

On 21 March 2018, the Hong Kong Legislative Council passed The Inland Revenue (Amendment) (No. 7) Bill 2017 which introduces the two-tiered profits tax rates regime that applies to years of assessment commencing on or after 1 April 2018. Under the two-tiered profits tax rates regime, the first HK\$2,000,000 of assessable profits of a qualifying group entity will be taxed at 8.25%, and assessable profits above HK\$2,000,000 will be taxed at 16.5%. The profits of group entities not qualifying for the two-tiered profits tax rates regime will continue to be taxed at a flat rate of 16.5%. The directors of the Company consider the amount involved upon implementation of the two-tiered profits tax rates regime as insignificant to the consolidated financial statements. Pursuant to the terms of the Agreements, if Anhui Huagang Bochen New Energy Co., Ltd. (安徽華港博臣新能源有限公司) (“Anhui Huagang”), a 50% joint venture company of Chengdu Huahan, could not obtain the Gas Business License on or before 30 June 2024 (deadline), the convertible bonds would be automatically cancelled on 1 July 2024, the Company would transfer the 35% of equity interest in Chengdu Huahan to the Vendor who would return the convertible bonds to the Company for nil consideration on or before 6 July 2024 (the “Restoration Clause”). As the Company was informed that the obtaining of the Gas Business License could be delayed and, on 12 June 2024, the Purchaser, the Vendor and Chengdu Huahan entered into a second supplemental agreement (the “Second Supplemental Agreement”) to the Agreement for extending the deadline to 30 November 2025 and the convertible bonds would then be automatically cancelled on 1 December 2025; the Company would re-transfer the 35% of equity interest in Chengdu Huahan to the Vendor who would return the convertible bonds to the Company for nil consideration on or before 6 December 2025.

As the aforementioned license was not obtained by the specified deadline, the re-transfer of the 35% equity interest in Chengdu Huahan and the cancellation of the convertible bonds were completed on 1 December 2025 in accordance with the terms of the Agreement.

Accordingly, the Group derecognised its entire interest in Chengdu Huahan during the year ended 31 March 2026. As at 31 March 2026, the Group had no remaining interest in Chengdu Huahan and recognised a gain on disposal of interest in an associate amounting to HK\$1,718,000 (2025: Nil) during the year.

28. CONVERTIBLE BONDS AND DERIVATIVE FINANCIAL INSTRUMENTS

The Company issued convertible bonds with a principal amount of HK\$52,000,000 on 5 December 2022 for the acquisition of the Group's associate, which principally holds 50% equity interest in Anhui Huagang (see Note 19).

The convertible bonds are denominated in Hong Kong dollars (other than the Group's functional currency), unsecured and interest-free.

The convertible bonds are comprised of convertible bonds (debt component) and derivative financial instruments (derivative component including conversion and early redemption options).

At initial recognition, both the convertible bonds and the derivative financial instruments are recognised at fair values amounting to HK\$28,000,000 and HK\$24,000,000 respectively.

The convertible bonds are subsequently measured at amortised cost with an effective interest rate of 22.9% per annum while the derivative financial instruments are measured at fair value with changes in fair value recognised in profit or loss.

Pursuant to the terms of the relevant agreements, the convertible bonds and the associated derivative financial instruments would be automatically cancelled in full at nil consideration if Anhui Huagang failed to obtain the specific gas business license on or before 30 November 2025.

As the license was not obtained by the specified deadline, the cancellation clause was triggered. Consequently, the outstanding convertible bonds and the derivative financial instruments were fully cancelled and derecognised by the Group with effect from 1 December 2025. The resulting gain on disposal of interest in an associate and derecognition of these financial instruments of HK\$1,718,000 has been recognised in the statement of profit or loss and other comprehensive income during the year ended 31 March 2026.

The Group may grant to any participant who has made valuable contributions to the business of the Group based on his or her performance and/or years of service, or is regarded as valuable resources of the Group based on his or her work experience and knowledge in the industry, or is expected to be able to contribute to the prosperity, business development or growth of the Group based on his or her business connection and network.

The Share Option Scheme became effective on 9 September 2016 and had a life of ten years from the date of its adoption. HK\$10.00 is payable by each eligible participant to the Company on acceptance of the grant of an option.

The 2016 Share Option Scheme was terminated in the annual general meeting held on 7 September 2023. No further options will be granted under the 2016 Share Option Scheme after its termination. In respect of all options which remained exercisable on such date, the provisions of the 2016 Share Option Scheme remained in full force and effect.

The overall limit on the number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and any other share option schemes of the Company must not in aggregate exceed 30% of the shares of the Company in issue from time to time. The total number of shares issued and to be issued upon exercise of the options granted to each eligible participant in any 12-month period must not exceed 1% of the aggregate number of shares of the Company in issue. Where any further grant of options to an eligible participant would result in the shares issued or to be issued upon exercise of all options granted and to be granted to such eligible participant in the 12-month period up to and including the date of such further grant representing in aggregate over 1% of the shares of the Company in issue, such further grant must be separately approved by the shareholders in general meeting with such an eligible participant and his associates abstaining from voting.

The exercise price of the share options is determined by the committee of the board of directors of the Company, but is at least the highest of: (a) the closing price of the shares as stated in the daily quotation sheet issued by the Stock Exchange on the date of grant; (b) the average of the closing prices of the shares as stated in the daily quotation sheets issued by the Stock Exchange over the five trading days immediately preceding the date of grant; and (c) the nominal value of a share.

31. RETIREMENT BENEFIT SCHEME

Since 1 December 2000, the Group has operated pension schemes under the rules and regulations of the Mandatory Provident Fund Scheme (“MPF Scheme”) for all qualifying employees in Hong Kong. The assets of the MPF Scheme are held separately in an independently managed fund. Contributions are made based on a percentage of the employee’s salaries and are charged to the consolidated statement of profit or loss and other comprehensive income as incurred in accordance with the rules of the MPF scheme.

The employees of the Group’s subsidiary in the PRC are members of a state-managed retirement benefit scheme operated by the PRC government. The subsidiary is required to contribute a specified percentage of payroll costs to the retirement benefit scheme to fund the benefits. The only obligations of the Group with respect to the retirement benefit scheme is to make the specified contributions.

The total cost charged to the consolidated statement of profit or loss and other comprehensive income of HK\$800,000 (2025: HK\$789,000) represents contributions paid to the schemes by the Group at rates specified in the rules of the schemes.

32. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the equity balance. The Group’s overall strategy remains unchanged from prior year.

The capital structure of the Group consists of debt, which includes bank borrowings, lease liabilities, loans from a shareholder and a controlling shareholder and convertible bonds and derivative financial instruments thereto as disclosed in notes 24, 25, 26 and 28, respectively, and equity attributable to owners of the Company, comprising issued share capital and reserves.

The directors of the Company review the capital structure on a continuous basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with capital. Based on recommendations of the directors of the Company, the Group will balance its overall capital structure through the issuance of new shares and raising of new borrowings.
